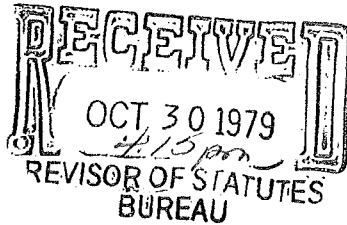

Analysis Prepared by Department of Natural Resources

The proposed revision of chapter NR 45, Wis. Adm. Code, comprises a total of 49 amendments. Most of the proposed changes (21), Sections 1-9, 11, 13, 30, 40, 41, 43, and 46-49 are minor and of a housekeeping nature.

Sections 10, 12, and 14-19 pertain to proposed changes (8) in camping regulations. The intent of the changes is to provide a better service to the camping public.

The most significant changes (20) involve the increase in user fees. The parks account balance is projected to have a deficit of over \$3 million by July 1, 1981 if fees remain at current levels with current programs continued. The Legislature increased the admission sticker fee from \$5 to \$10 for the resident annual; \$8 to \$15 for the nonresident annual; \$1.50 to \$2 for the resident daily and \$2.50 to \$3.00 for the nonresident daily with the passage of the budget. They also adjusted state park operations funding from 60% SEG user fee revenues and 40% GPR/ORAP to a 50/50 match on total park operation expenditures. The Legislature did not act on user fee increases since the statutes provide that they be set by administrative rule.

The proposed camping fee increases for Class 'A' campgrounds are from \$3.25 per day per camping party to \$4.00; for Class 'B' campgrounds from \$2.75 per day per camping party to \$3.50; and for Class 'C' campgrounds from \$2.25 per day per camping party to \$2.75. Using 1978 as a base year, the increase in camping fees should result in a revenue increase of slightly over \$200,000 per year.

The increase in user fees for the Peninsula golf course, Blue Mound swimming pool, Heritage Hill state park, Olympic Ice Rink, electricity and sewer is estimated to result in a revenue increase of about \$50,000 per year. The user fee increases along with the admission sticker increase and the 50/50 match should eliminate the deficit.

The rules and regulations contained in the Wisconsin Administrative Code chapter NR 45 are designed to control, regulate and eliminate conflicts between user groups and to protect the resource. Chapter NR 45 is revised periodically due to new legislation, changing land use patterns, budgetary needs and addition of new properties to the system.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 27.01, 28.02 and 227.014, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby repeals, renumbers, amends, repeals and recreates, and creates rules as follows:

SECTION 1 - Section NR 45.03 is repealed and recreated to read:

NR 45.03 Refuse. (1) It shall be unlawful for any person to dispose of any waste material in any manner except by burning, or by placing in receptacles or other locations provided for such purpose.

(2) It shall be unlawful for any person to dispose of any waste material in any waste disposal receptacle or location if such refuse or material is generated from a permanent or seasonal residence, or a business or other commercial operation.

(3) Refuse shall be packed out from those areas where waste disposal receptacles are not provided. Charcoal residue must be left in a grate or fireplace until cool, or placed in receptacles provided for such purpose.

SECTION 2 - Section NR 45.05(4) is created to read:

(4) Except as provided in sub. (3), it shall be unlawful for any person to allow his or her dog, cat or other animal on any cross-country ski trails during that period of the year when such trails are used for cross-country skiing, or at any time on nature trails.

SECTION 3 - Section NR 45.08(1) is amended to read:

(1) No person shall operate any vehicle at a speed in excess of 25 miles per hour or contrary to ~~official~~ state highway or department traffic signs. ~~in any state park, state fish hatchery or campground or picnic area in any state forest, or in the Bong recreation area or other lands under the management, supervision and control of the department.~~

SECTION 4 - Section NR 45.08(7) is created to read:

(7) It shall be unlawful to launch or land any hot air balloon unless it is done in accordance with the terms and conditions of a permit first obtained from the property manager.

SECTION 5 - Section NR 45.08(12) is created to read:

(12) No person shall fail to stop at a state park or state forest recreational entrance station when such stop is ordered by departmental signs.

SECTION 6 - Section NR 45.09(1)(e) is repealed.

SECTION 7 - Section NR 45.09(2)(b) is repealed and recreated to read:

(b) All waters within Governor Dodge state park, sections 35 and 36, T7N, R3E, and sections 1, 2, 10 and 11, T6N, R3E, town of Dodgeville, Iowa county, Wisconsin.

SECTION 8 - Section NR 45.12(2) is renumbered to be NR 45.12(3).

SECTION 9 - Section NR 45.12(2) is created to read:

(2) Any vehicle or watercraft in violation of sub. (1) may be towed off the property and stored at the owner's expense.

SECTION 10 - Section NR 45.13(2) is amended to read:

(2) Camping is prohibited except in designated camping areas, ~~on all lands under the management, supervision and control of the department.~~ It shall be unlawful to camp in such areas without a permit and the payment of the prescribed fees, ~~if any,~~ except when traveling by watercraft and camping for one night only at designated canoe campsites in the American Legion, Black River, Brule River, Flambeau River, and Northern Highland state forests and on designated state-owned islands outside state forest boundaries.

SECTION 11 - Section NR 45.13(2)(a) is repealed.

SECTION 12 - Section NR 45.13(3)(b) is repealed and recreated to read:

(b) Payment of camping fees is waived on state wildlife areas.

SECTION 13 - Section NR 45.13(7) is renumbered to be NR 45.13(8) and NR 45.13(8) is renumbered to be NR 45.13(7).

SECTION 14 - Section NR 45.13(11) is created to read:

(11) Violation of any state law or any rules of the department by a member of a camping party is cause for revocation of the camping permit.

SECTION 15 - Section NR 45.13(16)(j) is amended to read:

(j) Reservations will be accepted beginning the first ~~Tuesday~~ working day after January 1 for the period commencing May 1 and terminating September 30. Reservations for Peninsula state park will be accepted through the last weekend of October each year.

SECTION 16 - Section NR 45.13(17)(h) is repealed.

SECTION 17 Section NR 45.13(18)(f)6. is repealed.

SECTION 18 - Section NR 45.13(18)(i) is amended to read:

In no case will the reservation fee be refunded.

(j) Refund of all payments except the reservation fee will be made for cancellation of group camping reservations but only if notice of the cancellation is received 10 days or more in advance of the camping date. In no case will the reservation fee be refunded.

(2) It shall be unlawful for any person except registered campers in family campgrounds and customers in the Clausing Barn Restaurant at Old World Wisconsin to drink or possess any intoxicating liquor or fermented malt beverage in any state park, or Kettle Moraine and Point Beach state forests between March 31 and the Saturday immediately preceding Memorial Day.

SECTION 21 - Section NR 45.15(5) is created to read:

(5) It shall be unlawful for any person to possess or consume any food or beverage, including fermented malt beverage or intoxicating liquor, when on any observation tower.

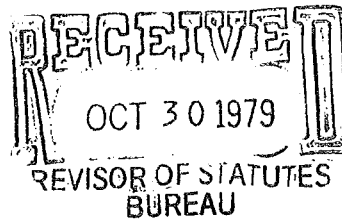




Dear Mr. Prestegard:
