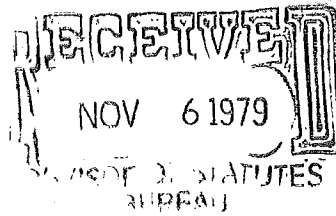


ORDER OF

DEPARTMENT OF INDUSTRY, LABOR AND HUMAN RELATIONS

Pursuant to authority vested in the Department of Industry, Labor and Human Relations by sections 101.01 to 101.211, Wis. Stats., the Department of Industry, Labor and Human Relations hereby amends, creates and adopts rules of Wisconsin Administrative Code Chapters Ind 50-64--Building and Heating, Ventilating and Air Conditioning Code.

The rules attached hereto shall become effective on January 1, 1980, as provided in section 227.026, Wis. Stats.
