



### ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

#### RENUMBERING AND CREATING RULES

IN THE MATTER of renumbering section NR 45.03 .
and creating sections NR 45.03(2) and
NR 45.09(10) of the Wisconsin Administrative
Code pertaining to restrictions on the Brule
River in the Brule River State Forest

PR-27-79

#### Analysis Prepared by Department of Natural Resources

The following revisions to chapter NR 45, Wis. Adm. Code, accomplish two objectives: 1) restriction on possession of nonreturnable beverage containers, cans and all glass bottles at designated boat launching sites; and 2) restriction on launching of all types of watercraft to designated sites on the Brule River within the Brule River State Forest.

These rules are designed to enhance environmental conditions around the Brule River. The first proposition would minimize littering in that there would be no incentive to bring nonreturnable beverage containers or glass bottles into the area. Second, there would be a sanction for people having nonreturnables or glass bottles in the only place they could launch watercraft on the Brule River in the Brule River State Forest.

The second proposition would prohibit the launching at any place other than a luanching site, so people could not launch a watercraft at any location they chose. This would then limit littering and environmental damage to these specific areas.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 28.01, 28.02, 28.03, 144.025 and 227.014, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby renumbers and creates rules interpreting sections 23.09, 23.11, 28.01, 28.02, 28.03 and 144.025, Wisconsin Statutes, as follows:

SECTION 1 - Section 45.03 is renumbered to be NR 45.03 (1).

SECTION 2 - Section NR 45.03 (2) is created to read:

(2) It shall be unlawful to possess nonreturnable beverage bottles, cans or containers or glass returnable bottles at designated launching sites on the

Brule river in the Brule River state forest. This provision does not apply to beverage bottles, cans or containers possessed in picnic areas, rest areas or parking lots.

SECTION 3 - Section NR 45.09 (10) is created to read:

- (10) On department-owned or managed lands on the Brule river in the Brule River state forest, boats or other watercraft may only be launched at the following designated launching sites:
  - (a) Stone's Bridge (T46N, R10W, sec. 30)
  - (b) Bois Brule campground (T47N, R10W, sec. 23)
  - (c) Highway #2 (T47N, R10W, sec. 14)
  - (d) Mouth of the Brule (T49N, R10W, sec. 10)

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on October 22, 1979 and March 27, 1980.

The rules contained herein shall take effect upon publication as provided in section 227.026(1) intro., Wisconsin Statutes.


