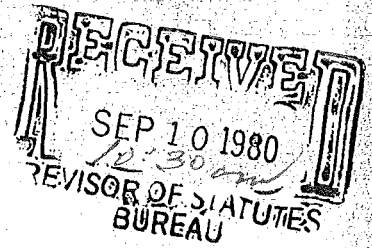

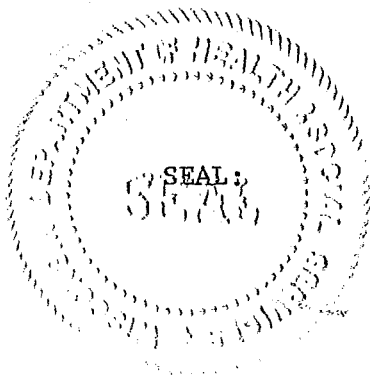

ORDER OF THE
DEPARTMENT OF HEALTH AND SOCIAL SERVICES
AMENDING RULES

Relating to rules concerning construction requirements for community-based residential facilities (HSS 3, Subchapter VI).

Analysis prepared by the Department of Health and Social Services:

The proposed amendment is needed to correct a rule numbering error within the text of the rule. The numbering error if left uncorrected could result in a misinterpretation of the intent of a section in the rule. The amendment is only a technical correction and in no way modifies the language or content of the rule. Since the rule amendment involves only a technical change it is being promulgated without public hearing as allowed under s.227.02(e), stats. There was no petition for a hearing so there are no modifications resulting from testimony. The Legislative Council found the proposed amendment to be appropriate and offered no comments or recommendations.

Pursuant to authority vested in the Department of Health and Social Services by section 50.02, Wis. Stats., and interpreting that section and section 50.03, Wis. Stats., the Department of Health and Social Services hereby amends rules as follows:


Section HSS 3.50 of the Wisconsin Administrative Code is amended to read:

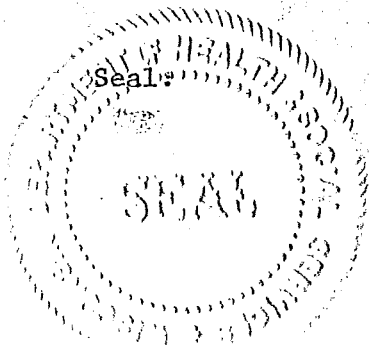
HSS 3.50 Scope. Sections HSS 3.50 to ~~3.56~~ - 3.57 apply to all CBRF.

The amendment contained in this order shall take effect on the first day of the month following its publication in the Wisconsin Administrative Register as provided in section 227.026(1) Stats.

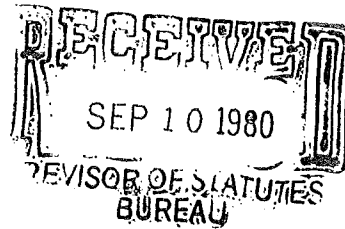
