

ORDER OF THE DEPARTMENT OF VETERANS AFFAIRS AMENDING RULES

Relating to a rule concerning Vietnam era veterans standard student educational budgets.

ANALYSIS PREPARED BY THE DEPARTMENT OF VETERANS AFFAIRS

This proposal increases by 10% the standard single and married student educational budgets upon which determinations of entitlement of veterans to receive Vietnam era veterans educational grants are based. The last increase in such budgets was based upon a May, 1979, Board proposal and the cost of living has increased by far more than 10% between May, 1979 and the present date.

Pursuant to authority vested in the Department of Veterans Affairs by Sections 45.28(1)(e) and 45.35(3), Wis. Stats., the Board of Veterans Affairs of the Department of Veterans Affairs hereby amends a rule interpreting Section 45.28, Wis. Stats., as follows:

VA 9.03 of the Wis. Adm. Code is amended to read:

VA 9.03 Standard Student Budgets. Standard single and married student educational budgets shall include standard living expenses budgets for single or married students, to which shall be added \$75.00 \$83.00 per dependent other than spouse per month, and all actual expenses for tuition, course fees, and book and materials costs for the academic year. Standard living expenses budgets shall be based upon 9 months living expenses of \$4,735 \$5,209 for single veterans or upon 9 months living expenses of \$7,264 \$7,990 for married veterans, per academic year.

The statutory provision relating to this rule is s. 45.28(1)(e), Stats. The rule shall take effect as provided in s. 227.026(1)(intro.), Stats.
