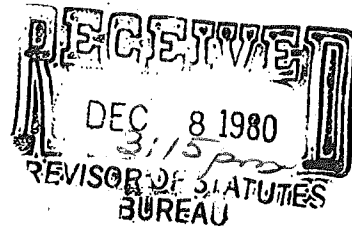

ORDER  
OF THE  
DEPARTMENT OF HEALTH AND SOCIAL SERVICES  
AMENDING RULES

Relating to rules concerning certification of ambulance providers under Title XIX of the Social Security Act.

Analysis prepared by the Department of Health and Social Services:

This revision interpreting section 49.45(2)(a)11, Wis. Stats., requires ambulances certified under the Medicaid program to meet only those standards set out in TRANS 157, the Department of Transportation administrative rules on inspection and approval of ambulances. Without the change, ambulances would have to meet two sets of criteria, the first conforming to TRANS 157 and the second conforming to federal guidelines stipulated by document KKK-A-1822-A entitled "Federal Specification -- Ambulance, Emergency Medical Care Service Vehicle."

The Legislative Council Clearinghouse offered no comments and made no recommendations on the proposed revision.

A 30-day notice that the agency would repeal and recreate the rule without public hearing unless petitioned for a hearing was published in the Wisconsin Administrative Register. No petition was received.

Pursuant to authority vested in the Department of Health and Social Services by section 49.45(10), Wis. Stats., the Department of Health and Social Services hereby repeals and recreates a rule interpreting section 49.45(2)(a)11, Wis. Stats., as follows:

Section HSS 105.38(1)(a) of the Wisconsin Administrative Code is repealed and recreated to read:

- (a) Ambulance inspection standards adopted by the Wisconsin Department of Transportation under s. 341.085, Stats. (Wisconsin Administrative Code Chapter Trans 157)

The amendment contained in this order shall take effect on the first day of the month following publication in the Wisconsin Administrative Register as provided in sec. 227.026(1), Wis. Stats.

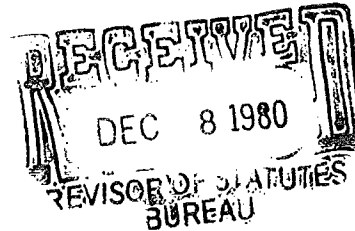
