

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

AMENDING RULES

IN THE MATTER of amending section NR 27.06(1) of the Wisconsin Administrative Code pertaining to endangered species permit requirements

ES-28-80



An addition to section NR 27.06(1), Wis. Adm. Code, will require Wisconsin endangered species permit to take, transport, possess or sell timber wolves. Wolves have heretofore been exempt from Wisconsin permits if they were federally permitted or exempt from a federal permit. Captive endangered species, including wolves, do not require federal permits as long as interstate commerce is not involved. The proposed rule addition will provide a means of regulating trade and care of privately owned timber wolves in Wisconsin. The number of such wolves in the state is growing.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 29.415 and 227.014, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby amends rules interpreting section 29.415, Wisconsin Statutes, as follows:

SECTION 1 - Section NR 27.06 (1) is amended to read:

NR 27.06 Exceptions to permit requirements. (1) Federal permits.

- (a) Exemptions. Any person taking, transporting, possessing or selling any wild animal or wild plant included in the U.S. foreign and native endangered and threatened species list does not need a state permit if such person has a federal permit, or if such person is exempt from a federal permit.
- (b) Notwithstanding par. (a), a person shall obtain a state permit before taking, transporting, possessing or selling a live timber wolf.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on July 24, 1980.

The rules contained herein shall take effect upon publication as provided in section 227.026(1) intro., Wisconsin Statutes.


