ORDER AMENDING AND ADOPTING RULES

## CR 81-44

Amended rules of the Department of Transportation relating to application deadline dates and principles of aid allocation under the elderly and handicapped transportation assistance program for counties, the urban mass transit operating assistance program, and the federal rural and small urban area public transportation assistance program.

## Text of Proposed Rule

Pursuant to authority vested in the Department of Transportation by secs. 85.05(3), 85.08(5)(c), 85.08(7), 110.06(1) and 227.014, Stats., the Department of Transportation hereby amends and adopts rules interpreting secs. 85.05, 85.08(5) and 85.08(7), Wis. Stats., as follows:

SECTION 1. TRANS 1.02(3) is amended to read:

TRANS 1.02(3) Subject to adjustments that ensure that counties-receive each county receives not less than  $\frac{1}{9000}$ in-1900-and- $\frac{1}{27000}$ -in-1901 <u>0.5</u> percent (rounded to the nearest thousand dollars) of the total annual appropriation for the program, the amount of aids allocated to each county shall equal the total amount available for allocation for the calendar year multiplied by the ratio of the number of elderly and handicapped persons in the county to the total number of elderly and handicapped persons in Wisconsin. (The final aids allocation figures for each county and the data and statistics used in making the aid allocations are available for inspection at the department upon request.)

SECTION 2. TRANS 1.06(2) and (3) are amended to read:

.

TRANS 1.06(2) Applications for grants of allocated aids shall be submitted to the department no later than November 15 December 1 of the year immediately preceeding the project year. Counties may request up to a 15-day 30-day extension of this due date and the department may grant such requests. Applications-shall-be-made-in-a-manner-and-form-prescribedby-the-department. No application received after January 1 of the project year shall be funded unless the Secretary of Transportation determines that a later date is appropriate in order to properly respond to an emergency situation. (3) <u>Applications shall</u> be made in a form and manner prescribed by the department. Applications shall include, but not be limited to, a project description, a project budget, and such other relevant information as the department may require to effectively evaluate the proposal. In addition the application shall include formal comments on the proposed project(s) by appropriate county agencies such as committees or commissions on aging and boards created under ss. 51.42 and 51.437, Stats.

SECTION 3. TRANS 4.07(2) is amended to read:

TRANS 4.07(2) Applications for aids shall be submitted to the department no later than December 1 of the eatendar year immediately preceeding the proposed project year. For purposes-of-this-chapter-a-"project-year"-is-defined-to-be a-calendar-year. The-department-does-not-accept-applications for-less-than-a-project-year. Applicants may request up to a 30-day extension of this due date and the department may grant such requests. No application received after January 1 of the project year shall be funded unless the Secretary of Transportation determines that a later date is appropriate in order to properly respond to an emergency situation.

SECTION 4. TRANS 4.07(5) and (6) are created to read:

TRANS 4.07(5) For purposes of this chapter a "project year" is defined to be a calendar year. The assisted transit services may be operated for less than a calendar year.

(6) The applicant shall submit the original of its application to the appropriate transportation district office of the department.

SECTION 5. TRANS 6.09(2) and (3) are repealed and recreated to read:

TRANS 6.09(2) Applications shall be submitted to the department no later than December 1 of the year immediately preceeding the project year. Applicants may request up to a 30-day extension of this date and the department may grant such requests. No application received after January 1 of the project year shall be funded unless the Secretary of Transportation determines that a later date is appropriate in order to properly respond to an emergency situation.

(3) For the purposes of this chapter, a "project year" is defined to be a calendar year. The assisted transit services may be operated for less than a calendar year. (End) The rules contained in this order shall take effect upon publication as provided in sec. 227.026(1)(intro.), Stats.
