



ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD RENUMBERING, RENUMBERING AND AMENDING, AND CREATING RULES

IN THE MATTER OF renumbering sections NR 25.08(4)(g), (5) and (6); renumbering and amending NR 25.08(4)(g) and (h) and (i); ; and creating NR 25.08(5) of the Wisconsin Administrative Code providing gear restrictions in restricted fishing areas of southern Green Bay

Analysis Prepared by the Department of Natural Resources

The rules renumber and amend section NR 25.08(5) and (6), renumber and amend section NR 25.08(4), and create NR 25.08(5)(intro.) establishing a new subsection which provides mesh size restrictions for nets fished in restricted fishing areas in southern Green Bay and to permit the use of pound nets for smelt in seasonally restricted fishing areas in southern Green Bay.

Pursuant to authority vested in the State of Wisconsin Natural Resources Board by ss. 29.085, 29.174, 29.33, and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby renumbers, amends, and creates rules interpreting s. 29.33, Stats., as follows:

SECTION 1 - Sections NR 25.08(4)(g) is renumbered NR 25.08(5)(a).

SECTION 2 - Section NR 25.08(4)(h) and (i) are renumbered NR 25.08(5)(b) and (c) and amended to read:

(b) That portion of southern Green Bay lying south of a line extending due west from the mouth of the Red river at 44°40'N, 87°45'W, from November 1 to the following May 19, except that gill nets in accordance with this chapter may be used to take whitefish in these waters and smelt pound nets may be fished after March 1.

- (c) That portion of southern Green Bay lying south of a line extending from the village of Red Banks in NW 1/4 SW 1/4, section 29, township 25 north, range 22 east westerly on a bearing of 277° to the point at which it intersects the Green Bay navigational channel at a bell buoy at 44°37'N, 87°56'W, thence northwesterly on a bearing of 328° to the point immediately adjoining Little Tail point at 44°40'N, thence due west to the shoreline from September 1 to the following May 19, except that gill nets in accordance with this chapter may be used to take whitefish in these waters and smelt pound nets may be fished after March 1.
- SECTION 3 Sections NR 25.08(5) and (6) are renumbered NR 25.08(6) and (7), respectively.
- SECTION 4 Section NR 25.08(5)(intro.) is created to read:
- (5) No nets of any kind except entrapping nets with a minimum mesh size of not less than 3" stretch measure between at least 2 hoops in the pot and seines with a minimum mesh size of not less than 3" stretch measure used for the taking of rough or detrimental fish, or entrapping gear with a minimum mesh size of not less than 3" stretch measure used for the taking of whitefish, or gill nets fished for rough fish under contract may be used, set, placed, or operated in the following waters of Lake Michigan:

The foregoing rule was approved and adopted by the State of Wisconsin Natural Resources Board on July 22, 1981.

The rules contained herein shall take effect as provided in s. 227.026(1)(intro.), Stats.
