### Analysis Prepared by Department of Natural Resources

In September, 1980, s. NR 30.01(1)(p), Wis. Adm. Code, establishing boundaries for intensive forest fire control areas was revised. Six townships in Oconto County that lie within the Nicolet National Forest were inadvertently omitted. The code is now being amended to include these townships.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 26.12(1), 227.014 and 227.02(1)(e), Stats., the State of Wisconsin Natural Resources Board hereby amends rules interpreting s. 26.12(1), Stats., as follows:

SECTION 1 - Section NR 30.01 (1) (p) is amended to read:

(p) Oconto county. All lands in: township 30 north, ranges 17, 18 and 19 east; township 31 north, ranges 15, 16, 17 and 18 east; township 32 north, ranges 15, 16 and 17 east; and township 33 north, ranges 15, 16 and 17 east.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on May 27, 1981.

The rules contained herein shall take effect as provided in s. 227.026 (1)(intro.), Stats.


