(10) CLARK COUNTY. (a) South fork Eau Claire river. That part of the south fork Eau Claire river beginning at the Mead Lake dam and extending downstream for a distance of 300 feet.

(24) GREEN LAKE COUNTY. (a) Silver creek. That part of the Silver creek beginning at the Fond du Lac - Green Lake county line and extending downstream to the Spaulding bridge located in the SE⁴ of the SE⁴, section 23, township 16 north, range 13 east.

(39) MARQUETTE COUNTY. (a) Montello river. That part of the Montello river beginning at the dam on the outlet of Lake Montello and extending downstream to the first bridge.
