ORDER OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES RENUMBERING AND AMENDING RULES

To renumber H 96 and H 98, and to amend HSS 198.16 and HSS 198.17, as renumbered, relating to restaurants and food vending machines.

Analysis Prepared by the Department of Health and Social Services

Chapters H 96 and H 98 of the Wisconsin Administrative Code are being renumbered to bring them into the HSS series within the Code. Eventually all chapters of rules administered by the Department will be grouped together in the multi-volume Code so that interested persons can easily identify and locate these rules.

The renumbered ch. HSS 198, which regulates vending machine operations and associated commissaries, is in addition being amended to replace outdated references and other language dealing with the appeals process for operators aggrieved by Department regulatory decisions and with the empowerment of the state health officer. The appeals process is made identical to the appeals process for aggrieved restaurant operators under renumbered ch. HSS 196.

Finally, the order changes several cross-references to rules in these two chapters as well as in eight other chapters of Department rules recently renumbered into the HSS series.

Pursuant to authority vested in the Department of Health and Social Services by ss.47.40(6)(h), 140.05(3), and 143.15(5) and (7), Stats., the Department of Health and Social Services hereby renumbers and amends rules interpreting ss.47.40, 50.50 to 50.71, 140.05(1), 140.05(17), and 143.15, Stats., as follows:

- SECTION 1. Chapter H 96 of the Wisconsin Administrative Code is renumbered HSS 196.
- SECTION 2. Chapter H 98 of the Wisconsin Administrative Code is renumbered HSS 198.
- SECTION 3. Section HSS 198.16 of the Wisconsin Administrative Code, as renumbered, is amended to read:

HSS 198.16 APPEAL BY THE OPERATOR. Any person aggrieved by an order of the department may appeal to the board secretary within 30 days after issuance of the order in-the-manner-prescribed-by-Wisr-Admr-Gode-sections-H-1*21-and-1*22. The department secretary shall at-its-next-regular-meeting-either reaffirm, summarily set aside or modify the order, or set a date for a hearing on the matter as provided-in-Wisr-Admr-Gode-sections-H-1*21-and-1*22. The action taken by the department secretary may either suspend the order or continue it in force pending determination of the issues. If the department secretary has summarily modified the order, the person aggrieved may appeal from the modified order as-herein provided.

SECTION 4. Section HSS 198.17 of the Wisconsin Administrative Code is amended to read:

HSS 198.17 STATE HEALTH OFFICER EMPOWERED TO ACT. The state health officer is empowered to act for the department in the administration and enforcement of all provisions of ch. 50, Stats., and the rules and-regulations of the department pertaining to Wisr-Admr-Gode-chr-H-98 vending machines.
