Analysis Prepared by Department of Natural Resources

Following a periodic review of the Wisconsin endangered and threatened species lists as required by s. 29.415, Stats., changes in the animal lists are proposed. The changes are based primarily on additional status information acquired during the past three years, including history of population declines, recent population increases, current status of populations and habitats, and threats to populations or habitats, or both. Specifically, the changes are:

1. Add Blanchard's Cricket Frog to the endangered amphibians list.
2. Add Red-necked Grebe to the threatened bird list.
3. Delete Spotted Salamander, Pickerel Frog, Burns Leopard Frog, River Redhorse, Mud Darter and Pugnose Shiner from the threatened amphibians and threatened fishes lists.
4. Change Double-crested Cormorant, Wood Turtle and Gilt Darter from the endangered to the threatened species list.
5. Change Loggerhead Shrike, Slender Glass Lizard, Goldeye and Pallid Shiner from the threatened to the endangered species list.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 29.415 and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby repeals, renumbers, renumbers and amends, amends, repeals and recreates, and creates rules interpreting s. 29.415, Stats., as follows:
