ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
REPEALING, AMENDING, REPEALING AND RECREATING, AND CREATING RULES

IN THE MATTER of repealing s. NR 45.16(1)(b)1.g. .
& (3); amending ss. NR 45.14(5)(intro.) & 45.15(3); .
repealing and recreating ss. NR 45.09(10), .
45.14(1), 45.15(1), 45.16(1)(b)1.e. & 45.23; and .
creating ss. NR 45.01(3)(u), 45.15(6), 45.16(1)(a)1.h & .
i., 45.25 and 45.26 of the Wisconsin Administrative .
Code pertaining to use regulations in state parks and .
forests. .

Analysis Prepared by Department of Natural Resources

The changes to ch. NR 45, Wis. Adm. Code, are needed to help facilitate the management and operation of the state parks and forests. The specific changes:

1. Add additional canoe access points in the Brule River State Forest.
 2. Amend the section on firearms to prohibit uncased guns in state forest campgrounds (they are already prohibited in state parks).
 3. Redraft a portion of the rule regarding personal conduct.
 4. Prohibit alcoholic beverages at Big Foot Beach state park.
 5. Reclassify Pike Lake, Mirror Lake, and Rocky Arbor campgrounds to a higher fee classification because of the facilities provided.
 6. Remove the Peninsula golf course fees from the code and set regulations to control use of the course. The fees will be posted at the park office and golf course clubhouse.
 7. Require that hikers stay on the signed hiking trail in the Parfrey's Glen Scientific Area and provide for protection of plants and animals in state scientific areas.
 8. Establish procedures for the use of Havenwoods State Forest Preserve and the Camp Wakanda Environmental Center.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 23.092, 23.11, 23.27, 27.01(1) and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby repeals, amends, repeals and recreates, and creates rules interpreting ss. 23.11 and 27.01(1), Stats., as follows:

SECTION 1. NR 45.09(10)(a), (b), (c) and (d) are repealed and recreated and (e), (f), (g), (h), (i) and (j) are created to read:

- (a) County highway P (T45N, R11W, sec. 8)
- (b) Stone Chimney fisher access (T46N, R11W, sec. 35)
- (c) Stone's bridge (T46N, R10W, sec. 30)
- (d) Winneboujou canoe landing (T47N, R10W, sec. 34)
- (e) Bois Brule campground (T47N, R10W, sec. 23)
- (f) Highway #2 (T47N, R10W, sec. 14)
- (g) Copper Range campground (T48N, R10W, sec. 26)
- (h) Pine Tree canoe landing (T48N, R10W, sec. 26)
- (i) Highway #13 (T49N, R10W, sec. 34)
- (j) Mouth of the Brule (T49N, R10W, sec. 10)

SECTION 2. NR 45.14(1) is repealed and recreated to read:

(1) No person may take, catch, kill, hunt, trap or pursue any wild animal or bird, or discharge any firearm, or have in possession or under control any firearm or air gun as defined in s. 939.22, Stats., or any slingshot or spring-load device designed for shooting a projectile unless the same is unstrung or enclosed in a carrying case while in any state park, fish

hatchery, or within 100 yards of any state campground, picnic area, or other special use area designated by the department by posted notice so as to prohibit the discharging of firearms in these areas. Nothing in this section shall prohibit the hunting of deer as provided in s. 29.57(4), Stats., in those state parks as provided in s. NR 10.27.

SECTION 3. NR 45.14(5)(intro.) is amended to read:

(5) No person ~~shall~~ may possess any loaded or uncased firearm or air gun while within the exterior boundary of state-owned lands posted with department signs in Dane, Dodge, Fond du Lac, Jefferson, Kenosha, Milwaukee, Ozaukee, Racine, Sheboygan, Walworth, Washington and Waukesha counties or on state forest lands in the Kettle Moraine or Point Beach state forests or on the Bong recreation area except as follows:

SECTION 4. NR 45.15(1) is repealed and recreated to read:

(1) No person may engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct, or conduct which tends to cause or provoke a disturbance or create a breach of the peace.

SECTION 5. NR 45.15(3) is amended to read:

(3) ~~It shall be unlawful for any~~ No person to may drink or possess any intoxicating liquor of fermented malt beverage in Heritage Hill state-park or Big Foot Beach state parks.

SECTION 6. NR 45.15(6) is created to read:

(6) Violations of any state law, administrative code, or any posted regulations at the Peninsula state park golf course by any person is cause for revocation of the golfing privilege.

SECTION 7. NR 45.16(1)(a)1.h. and i. are created to read:

- h. Mirror Lake
- i. Pike Lake

SECTION 8. NR 45.16(1)(b)1.e. is repealed and recreated to read:

- e. Rocky Arbor

SECTION 9. NR 45.16(1)(b)1.g. is repealed.

SECTION 10. NR 45.16(3) is repealed.

SECTION 11. NR 45.23 is repealed and recreated to read:

NR 45.23 STATE SCIENTIFIC AREAS Within the boundaries of state scientific areas posted with appropriate signs:

(1) No person may take, catch, kill, or remove any wild animal, including fish, or pick, collect or remove any plant or part thereof, or destroy, molest, deface, or remove any natural or archaeological feature, without a written permit issued by the department.

(2) The provisions of ss. NR 45.02, 45.03, 45.06, 45.07, 45.08, 45.10, 45.11, 45.12, 45.13, 45.14 and 45.15 apply to state scientific areas.

(3) This subsection applies to the Parfrey's Glen scientific area, section 23, township 11 north, range 7 east, and the Natural Bridge scientific area, section 17, township 10 north, range 5 east, Sauk county, Wisconsin.

(a) No person may possess or consume any food or beverage in Parfrey's Glen scientific area or the Natural Bridge scientific area.

(b) No person may enter or be in Parfrey's Glen scientific area and surrounding and adjacent state lands in sections 22 and 23, township 11 north, range 7 east, or the Natural Bridge scientific areas between the hours of 8:00 p.m. and 6:00 a.m.

(c) No person may hike in any area other than on a trail specifically designed and signed for that purpose unless authorized to do so in writing by the department.

SECTION 12. NR 45.25 is created to read:

NR 45.25 HAVENWOODS STATE FOREST PRESERVE. The following rules and regulations are established for the use of the Havenwoods state forest preserve in Milwaukee county.

(1) No person may drink or possess any intoxicating liquor or fermented malt beverage.

(2) Pets are prohibited within the preserve except for the use of a seeing eye dog by the blind.

(3) No person may enter or be within the exterior boundaries of the Havenwoods state forest preserve between the hours of 8:00 p.m. and 6:00 a.m. except when participating in an activity approved in advance by the property manager.

(4) No person may take, catch, kill, or remove any animal or pick, collect, or remove any plant or part thereof, without a written permit issued by the property manager.

(5) No person may launch or land any powered model aircraft unless done in accordance with the terms and conditions of a permit first obtained from the property manager.

SECTION 13. NR 45.26 is created to read:

NR 45.26 CAMP WAKANDA ENVIRONMENTAL CENTER - GOVERNOR NELSON STATE PARK.

(1) DESCRIPTION. The Camp Wakanda environmental center is described as all that portion of Governor Nelson state park in section 33, T8N, R9E, town of Westport, Dane county, lying south of Oak avenue posted with department signs including the Camp Wakanda building and enclosed shelter.

(2) LIQUOR AND ALCOHOLIC BEVERAGES. No person may drink or possess any intoxicating liquor or fermented malt beverage in the Camp Wakanda environmental center.

(3) RESTRICTIONS. (a) The center shall be open from 8:00 a.m. to 10:00 p.m. daily.

(b) Use of the center is restricted to nonprofit organizations for the sole purpose of conducting environmental, nature, or conservation education programs and to government agencies.

(c) At no time shall there be more than 100 persons per floor in the center or 20 persons in the enclosed shelter.

(d) Violations of any state law, administrative code, or any posted regulations at the Camp Wakanda environmental center by any person is cause for revocation of the permit.

(e) The use of amplifiers is prohibited except for educational films, video tapes, etc.

(4) FEES. The following fees are established for using and reserving the Camp Wakanda Environmental Center. (a) Center - \$50 per group per day per floor.

(b) Enclosed shelter - \$15 per group per day.

(c) Deposit - \$25 per reservation.

(d) Reservation - \$10 per reservation.

(e) The department may waive all fees for use by governmental agencies.

(5) RESERVATIONS. (a) Reservations will be accepted:

1. One year in advance of the desired occupancy date for youth groups.

2. Ten months in advance of the desired occupancy date for adult groups.

3. Nine months in advance of the desired occupancy date for governmental agencies.

(b) Reservations must arrive no later than 10 days prior to the date of occupancy.

(c) The reservation and deposit fees, as listed in this sub. (4), plus full payment in the form of a check or money order for the requested camping period must accompany the reservation application.

(d) Refund of the deposit and rental fees, as listed in this sub. (4), will be made for cancellation requests received 30 days or more in advance of the occupancy date. In no case will the reservation fee be refunded. No refund will be made for cancellations received less than 30 days in advance of the occupancy date.

(e) No group may occupy the facility for a period greater than 14 days in any 4-week period.

(f) No refund will be made for any part of any reservation period once the facility has been occupied for a portion of that time.

(g) Reservations must be made only on a department form and applications will be accepted by mail or in person.

(6) DEPOSIT. The deposit, as listed in this sub. (4), will be refunded within 3 weeks after the date of occupancy provided all rules and regulations have been complied with. If damages occur and the repair costs exceed the amount of the deposit, the group will be billed for the amount of the damages less the deposit. The park superintendent will assess and determine the amount and cost of damages. Failure to pay the cost of any damages within 30 days of the billing date will be considered a violation of this subsection.

(7) PETS. Pets are prohibited except for the use of a seeing eye dog by the blind.

(8) SUPERVISION. One adult will be in charge of each group. Groups of minors must be accompanied by one adult for each 10 minors.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on May 26, 1982.

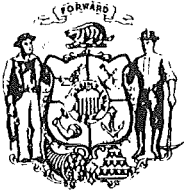


