RULES in FINAL DRAFT FORM

Rule: W.A.C.'s ILHR 82, ILHR 83, ILHR 84

Relating to: Renumbering the State Uniform Plumbing Code

Administrative rules to renumber chs. H 62, H 63 and H 80; and to amend H 80.02 (1), relating to the State Uniform Plumbing Code.

The Department of Industry, Labor and Human Relations is responsible for adopting and enforcing administrative rules relative to plumbing. The department is proposing to renumber chapters H 62, H 63 and H 80 of the State Uniform Plumbing Code to chapters ILHR 82, ILHR 83 and ILHR 84, respectively, so as to reflect the department's administration of these chapters. Other chapters of the plumbing code are in the process of being revised and are proposed to be appropriately renumbered.

Pursuant to the authority vested in the state of Wisconsin, Department of Industry, Labor and Human Relations by ss. 101.02 (1) and 145.02 (2), Stats., the Department of Industry, Labor and Human Relations hereby renumbers rules interpreting ch. 145, Stats., as follows:

SECTION 1. Chapter H 62 is renumbered ch. ILHR 82.

SECTION 2. Chapter H 63 is renumbered ch. ILHR 83.

SECTION 3. Chapter H 80 is renumbered ch. ILHR 84.

SECTION 4. H 80.02 (1) is amended to read:

H 80.02 (1) "Department" means the department of ~~health and social services~~
industry, labor and human relations.
