

ORDER

Pursuant to authority vested in the Funeral Directors and Embalmers Examining Board in ss. 15.08(5), 227.014 and 445.03(2), Stats., the Funeral Directors and Embalmers Examining Board hereby amends and adopts rules, interpreting ss. 445.01(5) and 445.105, Stats., as follows:

SECTION 1. Section FDE 2.10(1) of the Wisconsin administrative code is amended to read:

FDE 2.10(1) Before opening for business, and every 2 years thereafter, every a funeral establishment operator shall obtain a permit from the board through application upon a form furnished by the board. A permit will An original permit may not be granted to an operator of a new funeral establishment or to a new operator of an existing establishment without apreinspection an inspection. No permit may be granted to a funeral establishment which does not meet requirements in s. 445.01, Stats.

SECTION 2. Section FDE 2.10(2) of the Wisconsin administrative code is renumbered to FDE 2.10(3) and amended to read:

(3) A funeral establishment permit shall is not be transferable from one ~~premise~~ premises to another or from one operator to another.

SECTION 3. Section FDE 2.10(2) of the Wisconsin administrative code is created to read:

FDE 2.10(2) Prior to granting a permit to a licensed funeral establishment following a change in ownership, the board shall review the application to determine if an inspection is necessary.

The rule amendment and adoption contained in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026, Stats.
