ORDER OF THE COMMISSIONER OF INSURANCE

Amending a Rule

To amend s. Ins 17.28 (6) (i) relating to fees for podiatrists participating in the Patients Compensation Fund.

ANALYSIS PREPARED BY THE OFFICE OF THE COMMISSIONER OF INSURANCE

At their March 9, 1983 meeting, the Board of Governors of the Patients Compensation Fund passed a resolution creating a fee relativity schedule applying to several classes of health care providers. Those relativities were used in amending the fee schedule in s. Ins 17.28 (6) (i) to be effective July 1, 1983. Application of this fee schedule in s. Ins 17.28 (6) (i) resulted in a 341% increase in fees for some podiatrists. The Board reevaluated this increase and on July 12, 1983 at the recommendation of the Board's Actuarial Committee voted to lower the fees for surgical podiatrists and residents in post graduate podiatric medical education. The purpose of this amendment is to interpret s. 655.27 (3), Stats., to implement that fee reduction.


Pursuant to the authority vested in the Commissioner of Insurance by s. 655.27 (3), Stats., the Commissioner of Insurance hereby amends a rule interpreting s. 655.27 (3), Stats., as follows:

SECTION 1. Section Ins 17.28 (6) (i) is amended to read:

(i) For podiatrists (non surgical)	\$ 313.00	
For podiatrists (surgical)	\$3,874.00	\$1,756.00
For retired or part time podiatrists, non surgical office practice only, less than 500 hours practice per annum	\$ 188.00	
For residents in postgraduate podiatric medical education	\$2,324.00	\$1,054.00

The amendment of s. Ins 17.28 (6) (i) shall take effect on the first day of the month following its publication in the Wisconsin administrative register as provided in s. 227.026 (1) (intro.), Wis. Stats.
