

BOARD OF VOCATIONAL, TECHNICAL AND

ADULT EDUCATION

ADOPTING RULES RELATING TO FACILITIES DEVELOPMENT PROCEDURES

To create Chapter A-V 5 relating to facilities development procedures for vocational, technical and adult education districts.

Analysis prepared by the Wisconsin Board of Vocational, Technical and Adult Education.

Section 38.04(10), Stats., provides that the Board of Vocational, Technical and Adult Education "shall review and approve any proposals by district boards for land acquisition, additional or new facilities, rentals and remodeling of existing facilities, prior to the letting of contracts to construct, remodel, rent or incur debt for such facilities or land acquisition." This chapter is being proposed to set forth the Board's procedures for review of the proposals required to be submitted under s. 38.04(10), Stats.

A-V 5.01 sets forth the purpose of these rules.

A-V 5.02 defines certain terminology as used in these rules.

A-V 5.03 requires all proposals to be submitted 45 days prior to the board meeting at which the proposal will be reviewed.

A-V 5.04 requires district boards to submit proposal containing certain information and data for evaluation by the Board. This includes resolutions of the district board approving the project and requesting Board approval. Data and analyses relative to student needs, the needs of business and industry and costs is also required.

A-V 5.05 sets forth the information and data required from district boards relative to the fiscal impact of the proposal upon the district's budget resulting from the proposal.

A-V 5.06 requires the State Director to notify the district board, at least 14 days prior to board review as to his recommendation relative to the proposal.

A-V 5.07 requires the State Director to notify the distrit board of the Board's decision within 10 days of the Board's meeting to review the proposal.

A-V 5.08 sets forth the Board's critiera for review.

It should be noted that while the definitions contained in A-V 5.02 may be duplicative of those contained in ch. A-V 1, the Board intends to repeal ch. A-V 1 upon completion of all rule chapters currently being drafted. Additionally, rules governing compliance with s. 1.11, Stats., relative to environmental impacts, are currently in the development stage.

Pursuant to authority vested in the Board of Vocational,

Technical and Adult Education by section 227.014(2)(a), Stats.,

the Board proposes to adopt rules interpreting section 38.04(10),

Stats., as follows:


