ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING RULES

IN THE MATTER of amending NR 20.03(1)(a)1. of the Wisconsin Administrative Code to establish slot size limits on largemouth bass in 3 Langlade county lakes .

Analysis Prepared by the Department of Natural Resources

The rule establishes a slot size limit on largemouth bass in three Langlade county lakes whereby no largemouth bass between 12 and 16 inches may be kept. This will be a four-year test to determine what effect a slot size limit will have on bass and panfish populations in these three lakes. The objective of the test is to determine if slot size limits are effective regulations to improve the quality of largemouth bass fishing by increasing the number of large fish available for harvest and to determine if protecting the bass in this size range will increase predation on small panfish sufficiently to reduce their number and increase their growth rate.

Pursuant to authority vested in the State of Wisconsin Natural Resources Board by ss. 29.174, 227.014(2)(a) and 227.02(1)(e), Stats., the State of Wisconsin Natural Resources Board hereby amends the rule interpreting s. 29.174, Stats., as follows:

SECTION 1. NR 20.03(1)(a)1. is amended to read:
