#### ANALYSIS OF RULES

The Department of Industry, Labor and Human Relations is in the process of re-prefixing its administrative rules from the current "Ind" (established by the Industrial Commission) to "ILHR" and renumbering the chapters by subject topic. The numbering sequence for the Building Code remains unchanges; only the pre-fixes are affected by this proposal.
