ORDER OF THE CHIROPRACTIC  
EXAMINING BOARD REPEALING,  
AMENDING OR ADOPTING RULES

ORDER

Pursuant to authority vested in the Chiropractic Examining Board in ss. 15.08(5), 227.014 and ch. 446, Stats., the Chiropractic Examining Board hereby repeals, amends and adopts rules, interpreting s. 446.02(3), Stats., as follows:

SECTION 1. Chir 1.02 is amended to read:

Chir 1.02 FILING AN APPLICATION. Application for examination for license to practice chiropractic shall be made on forms prescribed by the board and filed with the secretary of in the board office at least ~~15~~ 30 days prior to the holding of any regular or special date of the examination by the board.

Note: Applications may be obtained upon request from the board office located at 1400 East Washington Avenue, Madison, Wisconsin 53702.

SECTION 2. Section Chir 1.05(1) is repealed.

The rules contained in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026, Stats.
