ORDER OF THE WISCONSIN NATURAL RESOURCES BOARD
AMENDING, AND REPEALING AND RECREATING RULES

.....
 IN THE MATTER OF amending s. NR 10.01(2)(f),
 and repealing and recreating s. NR 10.29 of
 the Wisconsin Administrative Code pertaining
 to regulation modification for the 1984 wild
 turkey hunting season.

Analysis Prepared by the
Department of Natural Resources

1. Turkey Hunting Permits - The number of turkey hunting permits controls the turkey harvest and hunting pressure in each Wild Turkey Hunting Zone for 3 separate hunting periods. The department proposes to increase the number of permits to be issued for the 1984 hunting season based upon the experience obtained during the 1983 season. Only bearded turkeys may be killed.
2. Wild Turkey Hunting Zones - Ten hunting zones are established for wild turkey hunting. Only zones 1, 2, 9 and 10 were open to hunting during the 1983 season. Zone 4 has been modified to coincide to huntable turkey populations and will be added to the open season area in 1984.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 29.103, 29.174(1) and (2), 227.02(1)(e) and 227.014, the State of Wisconsin Natural Resources Board hereby amends, and repeals and recreates rules interpreting ss. 29.103 and 29.174, Stats., as follows:

SECTION 1. NR 10.01(2)(f) is amended to read:




