ORDER

Pursuant to authority vested in the Barber Examining Board in ss. 15.08(5)(b), 227.014 and 457.02(1), Stats., the Barber Examining Board hereby amends, repeals and recreates and adopts rules, interpreting ss. 457.02(1) and 457.09(1) and (5), Stats., as follows:

SECTION 1. B 4.01(9) is repealed and recreated to read:

B 4.01(9) No credit may be granted to a student for a course or subject until the student receives a passing grade or demonstrates competency, as determined by the school.

SECTION 2. B 4.06 is amended to read:

B 4.06 SYLLABUS. Following are the subjects to be covered in barber school and the recommended hours for each student. The school may deviate from the recommended hours only with consent of the board. The hours listed below may be designated by a barber school as credit hours in a ratio of 36 hours of classroom and clinic instruction to one credit hour.

SECTION 3. B 5.05(2) is amended to read:

B 5.05(2) During the apprenticeship program all apprentices must shall satisfactorily complete 36-hours 1 credit hour of recordkeeping in a board-approved course. The recordkeeping course requirement is in addition to requirements specified in sub. (1).

The rules amended, repealed and recreated and adopted hereby shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026, Stats.
