STATE OF WISCONSIN

DEPARTMENT OF AGRICULTURE, TRADE AND CONSUMER PROTECTION ADOPTING RULES

- To create Ag 10.54(3)(c), relating to restrictions on the
- 2 exhibition of livestock infected with warts.

Analysis Prepared by the Department of Agriculture, Trade and Consumer Protection

The department's rule creating s. Ag 10.54(3)(c), Wis. Adm. Code restricts the exhibition of bovine animals infected with warts. Animals with warts must be isolated and removed from the exhibition premises. The fair veterinarian may authorize exhibition of the animal if, in the veterinarian's opinion, the wart is inactive and not capable of transmitting the disease.

- 3 Pursuant to the authority vested in the state of Wisconsin
- 4 department of agriculture, trade and consumer protection by
- 5 sections 93.07(1) and (10), Stats., the state of Wisconsin depart-
- 6 ment of agriculture, trade and consumer protection hereby adopts
- 7 rules interpreting sections 93.06(7), 93.07(10), 95.18, 95.19,
- 8 95.20, 95.22 and 95.23, Stats., as follows:
- 9 Section 1. Ag 10.54(3)(c) is created to read:
- 10 (c) Warts. Bovine animals infected with warts shall not be
- 11 exhibited at any fair or other livestock exhibition. Animals
- 12 found to be infected, or showing evidence of infection with warts
- 13 after arrival at a fair or other livestock exhibition shall be
- 14 immediately isolated from other animals susceptible to the disease

1	and removed from the premises within 24 hours. This subsection
2	does not apply to animals showing evidence of wart infection if,
3	in the opinion of the veterinarian in charge of the fair or
4	exhibition, the wart is inactive and not capable of transmitting
5	the disease.
6	SECTION 2. The rules contained in this order shall take
7	effect on the first day of the month following their publication
8	as provided in s. 227.026(1) (intro.), Stats.
