ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD  
AMENDING RULES

IN THE MATTER of amending s. 10.12(5)(d)2.b. :  
and c. of the Wisconsin Administrative : G-44-83  
Code pertaining to non-toxic shot :  
regulations :

Analysis Prepared by Department of Natural Resources

Lead poisoning occurs when waterfowl eat toxic (lead) pellets deposited by hunters. Wisconsin restricts waterfowl hunters to shotshells loaded with non-toxic (steel) pellets in certain areas to prevent ducks and geese from dying of lead poisoning. New information compiled by the Department indicates some new areas should be included in the non-toxic shot restriction. The new areas are Dane, Kenosha and Waushara Counties as well as an additional 500 feet of Green Bay.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 29.085, 29.174, and 227.014(2)(a), Stats., the State of Wisconsin Natural Resources Board hereby amends rules interpreting ss. 29.085 and 29.174, Stats., as follows:

SECTION 1. NR 10.12(5)(d)2.b. and c. are amended to read:

NR 10.12(5)(d)2.b. Eastern Wisconsin. In the Horicon and Central zones, shotshells containing non-toxic shot shall be required wherever hunting waterfowl and coot. Outside of these 2 zones, shotshells containing non-toxic shot shall be required on all waters and all areas within 150 yards of these waters in the counties of Calumet, Columbia, Dane, Dodge, Fond-du-Lac, Green Lake, Jefferson, Kenosha, Manitowoc, Marquette, Milwaukee, Outagamie, Ozaukee, Racine, Sheboygan, Walworth, Washington, Waukesha, Waupaca, and Winnebago all that part of Waushara county lying east of state highway 49.

c. Green Bay. The west 500 1,000 feet of Green Bay waters, all Brown county islands in Green Bay, all waters in Brown county northwest of the Fox river and east of U.S. highway 141, all waters of Oconto and Marinette counties east of U.S. highway 41 and all areas within 150 yards of these waters.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on February 22, 1984.

The rules contained herein shall take effect as provided in s. 227.026(1)(intro.), Stats.
