ORDER

Pursuant to authority vested in the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors in ss. 15.08(5)(b), 227.014(2)(a) and ch. 443, Stats., the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors hereby repeal and recreate rules, interpreting ss. 443.06, 443.07(1) and 443.09, Stats., as follows:

SECTION 1. A-E 1.15(3) is repealed and recreated to read:

A-E 1.15(3) EXAMINATION RETAKES. An applicant who fails any part of an examination may, upon request and payment of the reexamination fee, retake any part of the examination failed at a regularly scheduled administration of the examination. If an applicant fails an examination and does not pass the parts failed, or the current examination parts equivaent to the parts failed, within 4 years from the date the applicant first failed any or all parts of the examination, the applicant shall revert to the status of an original applicant and shall be required to pay the full application fee and take and pass all parts of the examination. In all cases, the board shall determine which parts of a current examination are equivalent to the examination parts failed by an applicant.

The rules repealed and recreated in this order shall take effect on the first day of the month following publication in the Wisconsin Administrative register, pursuant to s. 227.026, Stats.
