ADOPTING. AMENDING OR REPEALING RULES

- 1 To create section Ag 10.37 of the Wisconsin administrative
- 2 code relating to the certification or classification of cattle
- 3 herds according to paratuberculosis (Johne's disease) status.

## Analysis Prepared by the Department of Agriculture, Trade and Consumer Protection

S. Ag 10.37, Wis. Adm. Code, requires the department of agriculture, trade and consumer protection to designate herds of bovine cattle in one of 4 categories, depending on the paratuber-culosis status of the herd. (Paratuberculosis is also known as Johne's disease.) The 4 alternative categories are (1) "documented paratuberculosis-free herd," (2) "paratuberculosis program herd," (3) "paratuberculosis known positive herd," and (4) "paratuberculosis status unknown herd."

A herd may be certified as a "documented paratuberculosis-free herd" if the herd is routinely tested and found negative for paratuberculosis. Three consecutive herd tests are required for initial certification. Certification extends for a period of one year, and may be annually renewed on the basis of a single herd test.

If paratuberculosis is detected in a herd, the herd owner or manager may enter into a herd management agreement with the department, providing for appropriate measures to minimize further spread of the disease. (Measures may include calfhood vaccination.) A herd covered by a management agreement may be classified as a "paratuberculosis program herd."

If paratuberculosis is detected in a herd, but the herd owner does not enter into a management agreement with the department, the herd is to be classified as a "paratuberculosis known positive herd."

If a herd falls into none of the other 3 categories, it is to be classified as a "paratuberculosis status unknown herd." By initiating a routine testing program, the owner or manager of a "paratuberculosis status unknown herd" has an opportunity to acquire a "documented paratuberculosis-free herd" certification.

Pursuant to the authority vested in the state of Wisconsin

- 2 agriculture, trade and consumer protection hereby adopts rules
- 3 interpreting sections 93.07(10), 95.16, 95.22 and 95.23, Stats.,
- 4 as follows:
- 5 SECTION 1: Ag 10.37 is created to read:
- 6 Ag 10.37 PARATUBERCULOSIS; HERD CERTIFICATION OR CLASSIFI-
- 7 CATION. (1) DEFINITIONS. In this section: (a) "Herd sample"
- 8 means a collection of individual samples taken concurrently from
- 9 all herd member animals which have attained the age of 20 months
- 10 on or before the sample date.
- 11 (b) "Paratuberculosis" means the disease of cattle also
- 12 known as Johne's disease, caused by mycobacterium
- 13 paratuberculosis.
- 14 (c) "Sample" means a fecal sample or other procedure upon
- 15 which a test is based.
- 16 (d) "Test" means a fecal culture or other test approved by
- 17 the department for the diagnosis of paratuberculosis.
- 18 (2) CERTIFICATION OR CLASSIFICATION OF HERDS; REQUIREMENT.
- 19 The department shall certify or classify every Wisconsin herd of
- 20 cattle in one of 4 categories, based on the paratuberculosis
- 21 status of the herd, as provided in sub. (3).
- 22 (3) HERD CATEGORIES. (a) Documented paratuberculosis-free
- 23 herd. 1. A herd of cattle may be certified as a "documented
- 24 paratuberculosis-free herd" if the herd owner or herd manager sub-
- 25 mits documentation showing that the herd has been tested and found
- 26 negative for paratuberculosis, based on 3 consecutive herd sam-
- 27 ples. Each successive herd sample in the 3-sample series shall be

- 1 taken not less than 6 months nor more than one year after the pre-
- 2 ceding herd sample. Certification shall commence retroactively on
- 3 the most recent of the 3 herd sampling dates, and shall extend for
- 4 a period of one year from that date.
- 5 2. Certification may be renewed upon submission of a single
- 6 negative herd test, based on a herd sample taken no less than 8
- 7 nor more than 14 months after the beginning of the most recent
- 8 certification period. Renewal certification shall extend for a
- 9 period of one year, beginning at the end of the most recent
- 10 certification period. If a certification period expires before a
- 11 renewal certificate is issued, the herd shall be classified during
- 12 the interim as a "paratuberculosis status unknown herd" under
- 13 par. (d). Upon issuance of the renewal certificate, the renewal
- 14 certification period shall commence retroactively.
- 15 3. No person may claim or represent that an animal origi-
- 16 nates from a "documented paratuberculosis-free herd" unless the
- 17 animal has been a member of the herd for at least 60 days, and has
- 18 been tested and found negative for paratuberculosis as part of the
- 19 most recent herd sample and test, or was exempt from testing.
- 20 4. If testing of a herd certified as a "documented
- 21 paratuberculosis-free herd" discloses any positive paratuberculo-
- 22 sis reactors among the herd, the certification shall be summarily
- 23 revoked and the herd classified as a "paratuberculosis known posi-
- 24 tive reactor" herd under par. (c). If certification is revoked,
- 25 the herd owner or manager may enter into a herd management agree-
- 26 ment and qualify the herd for certification as a "paratuberculosis
- 27 program herd" under par. (b).

- 1 (b) Paratuberculosis program herd. The owner or manager of
- 2 a herd of cattle in which paratuberculosis has been diagnosed may
- 3 enter into a written herd management agreement with the depart-
- 4 ment. The herd management agreement shall include appropriate
- 5 measures, including possible calfhood vaccination, to control
- 6 paratuberculosis in the herd. The herd owner, the herd veterinar-
- 7 ian, and the department shall be parties to the herd management
- 8 agreement. Upon execution of a written herd management agreement,
- 9 the herd may be certified as a "paratuberculosis program herd."
- 10 The herd management agreement may be terminated by the department
- 11 for cause, or by the herd owner or manager upon 60 days prior
- 12 notice to the department. Termination of the herd management
- agreement terminates certification of the herd as a
- 14 "paratuberculosis program herd."
- 15 (c) Paratuberculosis known positive herd. A herd of cattle
- shall be classified as a "paratuberculosis known positive herd"
- 17 whenever any animal in the herd is tested and found positive for
- 18 paratuberculosis and the herd owner or manager does not enter into
- 19 a herd management agreement under par. (b).
- 20 (d) Paratuberculosis status unknown herd. A herd of cattle
- 21 shall be classified as a "paratuberculosis status unknown herd" if
- 22 the herd is not otherwise certified or classified under pars. (a)
- 23 through (c).
- 24 SECTION 2: The rules contained in this order shall take
- 25 effect on the first day of the month following their publication,
- 26 as provided in s. 227.026(1) (intro.), Stats.
