Order of the State Historical Society of Wisconsin

REPEALING AND RECREATING RULES

Relating to prohibiting parking at its premises and the State Historical Museum.

Analysis prepared by State Historical Society of Wisconsin. HS 1.01 authorizes parking regulation only at the State Historical Society building at 816 State Street and not at the Society's History Museum at 30 North Carroll Street. Recreated rule HS 1.01 adds needed authority to regulate parking at that Museum.

Pursuant to the authority vested in the State Historical Society Board of Curators by s. 44.21 Stats., the Board of Curators hereby repeals and recreates rules interpreting s. 44.21 as follows:

Section HS 1.01 of the Wisconsin Administrative Code is repealed and recreated to read:

Parking is prohibited on the grounds of the state historical society premises located at 816 State St. (also known as the corner of State and Langdon streets) and at the state history museum premises at 30 N. Carroll St. (also known as Carroll and Mifflin streets) Madison, WI, except for society vehicles and such other vehicles as may be allowed by the society director, who may issue parking permits for the vehicles allowed; the parking areas shall be appropriately posted. Violation of this section may result in a forfeiture to the state of not more than \$25. This rule is effective in accordance with s. 227.026 (1) (intro) Stats.
