ORDER OF THE STATE SUPERINTENDENT OF PUBLIC INSTRUCTION CREATING RULES

- 1 To create Chapter PI 17 relating to the vocational education instructor
- 2 occupational competency program.

Analysis Prepared by the Department of Public Instruction

Chapter 370, Laws of 1983, establishes a vocational education instructor occupational competency program (effective July 1, 1984). The program which shall be jointly administered by the Department of Public Instruction and the VTAE Board is designed to provide vocational education instructors in public high schools and district schools with temporary work experience in business and industry in order to improve their knowledge and skills in the subjects they teach. The rules outline the procedures the school boards must follow in applying for grants, the assurances that must be provided, and the criteria the department will use in approving grants.

- 3 Pursuant to the authority vested in the Department of Public Instruction
- 4 by s. 227.014(2)(a), Stats., the State Superintendent hereby creates rules
- 5 interpreting s. 38.32(4), Stats., as follows:
- 6 SECTION 1. CHAPTER PI 17(TITLE) is created to read:
- 7 PI 17 VOCATIONAL EDUCATION INSTRUCTOR OCCUPATIONAL COMPETENCY PROGRAM
- 8 SECTION 2. PI 17.01 through PI 17.06 are created to read:
- 9 PI 17.01 PURPOSE AND APPLICATION. The purpose of this chapter is to
- 10 establish policies and procedures and to administratively interpret s. 38.32,
- 11 Stats., relating to the vocational education instructor occupational compe-
- 12 tency program to be established by the department. This chapter is adopted

- 6 (1) "Department" means the department of public instruction.
- 7 (2) "Program" means the vocational education instructor occupational
- 8 competency program.
- 9 (3) "Public high school" means a high school operated by a public
- 10 school board.
- 11 (4) "Public school board" means the school board or board of education
- 12 in charge of the schools of a school district.
- 13 (5) "School district" means a school district as defined under
- 14 s. 115.01(3), Stats.
- 15 (6) "School district administrator" means the school district super-
- 16 intendent, supervising principal or other person who acts as the adminis-
- 17 trative head of a school district and holds an administrator's license.

- 24 (1) The program shall be designed to provide vocational education
- 25 instructors in public high schools with temporary work experience in

- 2 the subjects they teach.
- 3 (2) To the extent possible, grants awarded under the program shall be
- 4 equally distributed on a statewide basis.
- 5 (3) No person employed by a business or industry participating in this
- 6 program may be terminated from employment, laid-off or otherwise displaced
- 7 as a result of that business or industry participating in the program.
- 8 (4) No grant may be awarded to any public school board that conflicts
- 9 with a collective bargaining agreement.
- 10 PI 17.04 GRANT APPLICATIONS.
- 11 (1) Public school districts shall disseminate information to vocational
- 12 education instructors informing them of the program.
- 13 (2) A vocational education instructor desiring to participate in the
- 14 program shall inform his or her school district administrator of his or her
- 15 intent to be considered for funding under the program. Participation in
- 16 the program shall be be voluntary on the part of the vocational education
- 17 instructor and the public school board.
- 18 (3) If the public school board determines that the vocational education
- 19 instructor should be allowed to participate in the program, it may file an
- 20 application for a grant.
- 21 (4) The application for a grant shall be on forms prescribed jointly
- 22 by the board of vocational, technical and adult education and the department,
- 23 and shall be filed with the department.

- 2 (1) Grant awards for vocational education instructors employed by
- 3 high schools in public school districts shall be made by the state
- 4 superintendent.
- 5 (2) In determining whether a grant award will be made, based upon a
- 6 particular application, the following criteria shall be applied:
- 7 (a) The potential for improved instruction resulting from participation
- 8 in the project.
- 9 (b) The need for upgrading the vocational education instructor's skills
- 10 after considering technological advances in the subject area taught by that
- 11 person.
- 12 (c) The number of grant awards made in that particular cooperative
- 13 educational service agency (CESA) area.
- 14 (d) The availability of funds.
- 15 PI 17.06 CONDITIONS OF THE GRANT AWARD.
- 16 (1) Each business or industry participating in the program shall
- 17 certify that no person employed by that business or industry will be
- 18 terminated from employment, laid-off or otherwise displaced as a result of
- 19 that business or industry participating in the program.
- 20 (2) Grant awards under the program shall only be used to partially
- 21 pay the salaries and fringe benefits of teachers participating in the
- 22 program.
- 23 (3) Any grant award received by a public school board shall at a
- 24 minimum be equally matched by the public school board.
- 25 (4) Each vocational education instructor shall, within 60 days

l of completion of participation in the program and on forms provided by

2 the department, submit a written evaluation to the public school board

3 and the department which evaluates the work experience and provides proposals

4 for incorporating any new ideas into the curriculum.

5 (5) Prior to September 15, on forms provided by the department, each

6 participating public school district and business and industry shall evaluate

7 its participation in the program and forward a copy of this evaluation to

8 the department.
