

ORDER

Pursuant to authority vested in the Accounting Examining Board in ss. 15.08(5)(b), 227.014(2)(b), 442.01(1) and 442.04(5), Stats., the Accounting Examining Board hereby repeals, amends and adopts rules, interpreting ss. 15.08(5)(b) and 111.335(1)(c), Stats., and 442.01(1) and 442.04(5), as affected by ch. 380, Laws of 1981, as follows:

SECTION 1. ATTENTION: REVISOR

Remove the note following s. Accy 1.401(2)(b):

SECTION 2. Accy 1.401(2)(bm) is created to read:

Accy 1.401(2)(bm) A certified public accountant or public accountant shall notify the board in writing within 60 days after being convicted of a crime.

SECTION 3. Accy 1.404(2)(b)1. is amended to read:

Accy 1.404(2)(b)1. Detracts from the public image of the profession, as for example, on ~~moral or~~ legal grounds, or conduct which would constitute an act discreditable to the profession; or,

SECTION 4. Chapter Accy 6 is repealed.

The rules contained in this order shall take effect pursuant to ss. 227.026(1)(a) and 442.01(1), Stats.
