

ORDER OF THE
DEPARTMENT OF ADMINISTRATION
ADOPTING RULES

Relating to rules concerning low-level radioactive waste and establishing a schedule of fees to be paid by nuclear power plant operators.

To create ch. Adm 42 of the Wisconsin Administrative Code.

Analysis prepared by the Department of Administration:

Section 16.115, Stats., created by 1983 Wisconsin Act 393, as amended by 1983 Wisconsin Act 543, requires that the department of administration promulgate rules to establish a schedule of fees to be paid by nuclear power plant operators for the support of the Wisconsin Low-Level Radioactive Waste Council and for the support of the Wisconsin Commissioner to the Midwest Low-Level Radioactive Waste Compact. Fees will be collected from electric utilities which are nuclear power plant operators.

The rule will not have any effect on small businesses as defined in s. 227.016, Stats.

Pursuant to the authority vested in the Department of Administration by ss. 16.004(1) and 16.115 (1), Stats., the Department hereby adopts rules interpreting s. 16.115, Stats., as follows:

SECTION 1. Adm 42.01 and Adm 42.02 are created to read:

Adm 42.01 AUTHORITY. Section 16.115, stats., requires the department of administration to establish a schedule of fees to be paid by nuclear power plant operators.

Note: s. 16.115(2), stats., directs the department to establish a second schedule of annual fees which shall begin with the operation of a regional low-level radioactive disposal facility.

Adm 42.02 SCHEDULE OF FEES. (1) The following is the schedule of fees to be paid by nuclear power plant operators for each nuclear reactor:

- (a) Fiscal year 1983-84 = \$9,650.00
- (b) Fiscal year 1984-85 = \$1,150.00
- (c) Each fiscal year thereafter = \$1,150.00

Note: Fiscal years run from July 1 of the first year, through June 30 of the second year.

(2) The amounts in the schedule shall be due and payable to the department of administration before the end of the appropriate fiscal year, except the fiscal year 1983-84, which amount shall be due within 30 days of the effective date of this section.

Note: Section 16.115 (2), Stats., directs the department to establish a second schedule of annual fees which shall begin with the operation of a regional low-level radioactive disposal facility.

The rule creation contained in this order shall take effect as provided in s. 227.026(1)(intro.), Stats.
