ORDER OF THE NATURAL RESOURCES BOARD AMENDING AND CREATING RULES

IN THE MATTER of amending s. NR 10.01 (3)(g), Wisconsin Administrative Code, pertaining to black bear hunting regulations.

G-2-85

Analysis Prepared by Department of Natural Resources

The black bear harvest has exceeded biological capabilities in recent years. To restore the bear population to a fall, prehunt level of 5,500, the annual bear kill must be limited to 500 or less for the next 3 or 4 years. Because the agency lacks Legislative authority to establish harvest quotas or limit hunter participation and a limited (2-day) season may produce kill levels in excess of 500, a closed season is the only reasonable alternative.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 29.085, 29.174(1) and 227.014(2)(a), Stats., the State of Wisconsin Natural Resources Board hereby amends rules interpreting s. 29.174(1), Stats., as follows:

SECTION 1. NR 10.01(3)(g) is amended to read:

1.	'Firearm season - In all counties of the state	Beginning-on-the-3rd Saturday-in-September-and eontinuing-for-16 eonsecutive-days None	<u>None</u>
2.	'Bow and arrow season' - In all counties of the state	Beginning-on-the-3rd Saturday-in-September-and continuing-through-the Sunday-immediately-prior-to the-opening-of-the-gun-deer season None	One-adult-bear per-season-with bow-and-arrow or-firearm

The foregoing rules were adopted by the Natural Resources Board on June 4, 1985.

The rules contained herein shall take effect as provided in s. 227.026(1)(intro.), Stats.
