




(b) *Mud lake*. Township 11 north, range 10 east, town of Lowville.




(4) CRAWFORD COUNTY. (a) *Harpers slough (Pool 9)*. Township 9 north, range 6 west, town of Seneca.




(5) GRANT COUNTY. (a) *Dago slough (Pool 11)*. Township 2 north, range 4 west, town of Seneca.



(5) WAUKESHA COUNTY. (a) *Vernon wildlife area*. Township 5 north, range 18 and 19 east, town of Muckwonago.



(1) WALWORTH COUNTY. (a) *Delavan Lake*. Township 2 north, range 16 east, town of Delavan.




(2) WAUKESHA COUNTY. (a) *Big Muskego Lake*. Township 5 north, range 20 east, town of Muskego.


