ORDER

OF THE

STATE ELECTIONS BOARD

To repeal ElBd 1.03 relating to the requirement to file duplicate copies of campaign finance reports with county clerks.

Analysis Prepared by State Elections Board

This rule interprets s. 11.09 (1) and (2), Stats., that requires the elections board to transmit to the appropriate county clerk a certified duplicate copy of the campaign finance reports of each registrant required to file reports with the board. Section 11.09 (1), Stats., however, was repealed on July 2, 1983, thereby eliminating the primary statutory basis for this rule. Section 11.09 (2), Stats., is a provision that the board is recommending the legislature repeal because this requirement for the board to send duplicate reports to county clerks serves no useful public purpose. This rule, therefore, is unnecessary in the board's judgment.

Pursuant to the authority vested in the state of Wisconsin elections board by s. 227.014 (2)(a), Stats., the elections board hereby repeals its rule interpreting ss. 11.09 (1) and (2), Stats., as follows:

Section 1. ElBd 1.03 is repealed.

The repeal of this rule takes effect on the first day of the month following publication in the Wisconsin administrative register pursuant to s. 227.06 (1)(intro.), Stats.
