ORDER OF THE

ADOPTING RULES

Relating to time for review and determination on lobbyist license application.

To renumber SS 2.02(5) and to create SS 2.02(5)(b) of the Wisconsin Administrative Code.

Analysis prepared by the Office of the Secretary of State

The proposed revision to Chapter SS 2, (Lobbying) Wis. Adm. Code, pertains to lobbyist license review time periods. 1983 Wisconsin Act 91 created s. 227.0105, Stat., mandating that any administrative rule which includes requirements for a business to obtain a permit shall specify the number of business days within which the agency will review and make a determination on the permit application. Act 91 also created s. 560.41, Stats., which defines "permit" broadly, to mean "...any approval of a regulatory agency required as a condition of operating a business in this state".

In response to these statutory mandates, the rule revisions proposed here insert the required permit review time periods where not already present.

This rule revision does not represent any change in existing agency review activity.

There is no fiscal effect anticipated from the promulgation of these rules.

The rules will not have any effect on small businesses as defined in s. 227.016, Stats.

Pursuant to the authority vested in the Office of the Secretary of State by ss. 13.685, 227.015 and 227.014(2)(a), Stats., the Office hereby adopts rules interpreting ss. 13.63(1) and 13.65(3), Stats., as follows:

SECTION 1. SS 2.02(5) is renumbered to SS 2.02(5)(a).

SECTION 2. SS 2.02(5)(b) is created to read:

SS 2.02(5)(b) The secretary shall review and make a determination on the Application for Licensing as a Lobbyist within 5 business days of receipt of the completed application materials.

Pursuant to s. 227.026(1)(intro.), Stats., these rules shall take effect on the first day of the month following publication in the Wisconsin Administrative Register.
