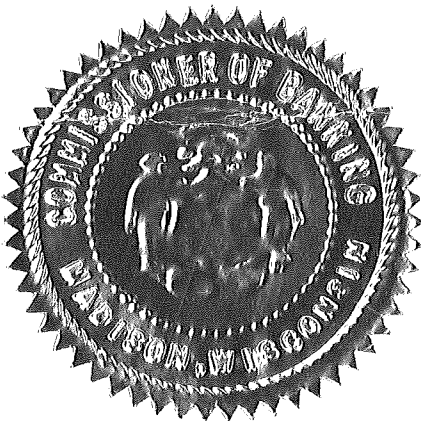

ORDER OF THE OFFICE OF COMMISSIONER OF BANKING

REPEALING RULES

To repeal Chapter Bkg. 13 relating to public deposits and depositories.

Final Draft Form

Analysis prepared by the Office of Commissioner of Banking.

1985 Wisconsin Act 25 substantially amended Chapter 34, Stats., governing public deposits and public depositories. Specifically, Act 25 repealed the authority of the Commissioner to make assessments payable to the State Deposit Guarantee Fund, to establish the qualifications for banks, credit unions or savings and loans to act as public depositories and to fix the maximum total public deposits for public depositories.


As a result of these amendments the rules in Chapter Bkg. 13 are repealed as obsolete.

Pursuant to the authority vested in the Commissioner of Banking pursuant to Sec. 34.03, 220.02(2) and 227.014, Stats., the Commissioner hereby repeals Chapter Bkg. 13 (Title) and Bkg. 13.01 through 13.04 interpreting Chapter 34, Stats., as follows:

SECTION 1. Chapter 13 is repealed.

The repeals contained in this order shall take effect as provided in Sec. 227.026(1)(intro.), Stats.
