## ORDER

Pursuant to authority vested in the veterinary examining board in ss. 15.08(5)(b), 19.34, 227.014(2)(a), 453.02(2), 453.05(1), 453.06(1) and (3)(a)2. and 453.08, Stats., the veterinary examining board hereby repeals, amends and adopts rules, interpreting ss. 19.33(5), 227.0105(2), 453.02(7), 453.05(1), 453.06(1) and (3)(a)2. and 453.07, Stats., as follows:

SECTION 1. VE 2.04 is repealed and recreated to read:

VE 2.04 LICENSE; APPLICATION. (1) EXAMINATION. An application for examination for a license to practice veterinary medicine shall be made on a form prescribed by the board and shall be accompanied by the fee specified in s. 440.05(1), Stats.

Note: Application forms may be obtained upon request to the board office, 1400 East Washington Avenue, Madison, Wisconsin.

- (2) REAPPLICATION REQUIRED. If an applicant withdraws from an examination after notification from the board of eligibility to take the next scheduled examination, the applicant shall reapply in order to be scheduled to take any subsequent examination. The board shall notify the applicant within 30 business days after receipt of a completed application whether the application is approved or denied.
- (3) EXAMINATION WAIVER. The board shall waive the requirement for the national board examination and clinical competency test for any applicant who submits evidence satisfactory to the board that the applicant has achieved a grade of no less than 70.0 on each of the examinations.

SECTION 2. VE 2.08(1)(intro.) is amended to read:

VE 2.08(1)(intro.) A graduate of a veterinary college approved by the board who meets all requirements for examination may be granted a temporary permit to practice veterinary medicine until the results of the next examination are known provided if the applicant is employed and supervised by and practices under the direct supervision of a veterinarian licensed in Wisconsin. Applicants for a temporary permit shall provide the board:

SECTION 3. VE 2.08(1)(d) is created to read:

VE 2.08(1)(d) Evidence of successful completion of the national board examination and the clinical competency test; or evidence that the applicant

is either scheduled to take the national board examination and clinical competency test for the first time; or, is awaiting results on the national board examination and clinical competency test.

SECTION 4. VE 2.09(1) is amended to read:

VE 2.09(1) The examination for a veterinary license consists of a written national board examination, clinical competency test and a principles of practice examination. An applicant may be admitted to the principles of practice examination only if the applicant has achieved a grade of no less than 70.0 on both the national board examination and clinical competency test. An applicant who has been examined in another licensing jurisdiction shall provide evidence satisfactory to the board of having achieved a score of no less than 70.0 on both the national board examination and clinical competency test.

SECTION 5. VE 3.01(1) and (2) are renumbered (2) and (7).

SECTION 6. VE 3.01(4) is renumbered (6).

SECTION 7. VE 3.01(3) is renumbered (4) and repealed and recreated to read:

VE 3.01(4) "Direct supervision" means to direct, supervise and inspect at first hand and while in the immediate visual area of the supervising veterinarian the implementation of veterinary services rendered.

• SECTION 8. VE 3.01(6) and (7) are renumbered (3) and (1).

SECTION 9. VE 3.01(8) to (10) are repealed.

SECTION 10. VE 3.02(12) to (23) are renumbered 3.02(15) to (26).

SECTION 11. VE 3.02(11)(a) and (b) are renumbered 3.02(12) and (13).

SECTION 12. VE 3.02(14) is created to read:

VE 3.02(14) Knowingly having a professional association with, or employing any person not licensed to practice veterinary medicine except under the direct supervision of a veterinarian.

SECTION 13. VE 3.02(18) as renumbered is repealed and recreated to read:

VE 3.02(18) Advertising in a manner which is false, fraudulent, misleading or deceptive, or knowingly maintaining a professional association with another veterinarian or veterinary firm that advertises in a manner which is false, fraudulent, misleading or deceptive.

SECTION 14. VE 4.02(2) is renumbered 2.10 and amended to read:

VE 2.10 EXAMINATION REVIEW. Unsuccessful applicants may review their written exam only the principles of practice examination at the board office during regular office hours upon written request within 30 days after notice of denial.

SECTION 15. CH. VE 5 is repealed.

SECTION 16. VE 6.04 is amended to read:

VE 6.04 EXAMINATION FOR CERTIFICATE. The 2-part examination for certification shall consist of a written the national board and a principles of practice practical examination. Each of these parts shall constitute 50% of the final grade. A total score of 70% is passing. An applicant shall receive an average grade of the 2 parts of no less than 70.0 for successful completion of the examination.

SECTION 17. VE 7.02(intro.) is amended to read:

VE 7.02(intro.) The following acts are limited to licensed veterinarians and therefore prohibited for certified animal technicians except under the direct supervision of a veterinarian:

SECTION 18. VE 7.02(4) is amended to read:

VE 7.02(4) Administration of general anesthesia except under the supervision of the licensed veterinarian.
