ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD REPEALING AND AMENDING RULES

IN THE MATTER of repealing ss. NR 124.07(4)(a)5.
and 124.08(1) to (4); and amending s.
NR 124.08(5)(a), Wisconsin Administrative Code
pertaining to the Wisconsin Fund Private Sewage
Grant Program
.

Analysis by Department of Natural Resources

Statutes interpreted: ss. 144.245(9)(g) and (11)(b) and (c) as affected by 1985 Wisconsin Act 29.

1985 Wisconsin Act 29 revises the method the Department must use to allocate grant funds to participating governmental units and revises the system to be used by governmental units for distributing grant funds to eligible applicants. Consequently, ss. NR 124.07(4)(a)5. and 124.08(1) to (4) are in conflict with statute. The attached order repeals those sections.

In addition, the attached order amends s. NR 124.08(5)(a) to delete the second sentence of this provision which references the repealed sections.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 144.025, 144.245(2), and 227.02(1)(b), Stats., the State of Wisconsin Natural Resources Board hereby repeals and amends rules interpreting s. 144.245, Stats., as follows:

SECTION 1. NR 124.07(4)(a)5. and NR 124.08(1) to (4) are repealed.

SECTION 2. NR 124.08(5)(a) is amended to read:

NR 124.08(5) REVISION OF ALLOCATION OR AWARD. (a) If the department finds that a property owner listed in the application of a governmental unit does not meet the eligibility requirements under s. 144.245(5), Stats., the department may reduce an allocation to the governmental unit in the current or in a following fiscal year. Fer-each-ineligible-owner-the-amount-of-funds-withheld-from-the-allocation-shall-be-equal-to-the-proration-factor-for-each-year-the-ineligible-owner-was-listed-in-the-governmental-units-application-

The foregoing amendments were approved and adopted by the State of
