ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD  
REPEALING AND AMENDING RULES

 IN THE MATTER of repealing ss. NR 128.30(3)(a),  
 (6)(c) and (7) and amending statutory references  
 in the Wisconsin Administrative Code pertaining  
 to the Wisconsin Fund Septic System Grant Program  
 .....

Analysis by Department of Natural Resources

The priority method of distributing grant funds under the Wisconsin Fund Septic System Grant Program was repealed and replaced with an allocation formula by 1983 Wisconsin Act 545. Act 545 also moved the application deadline back from January 1 to the end of the previous fiscal year (June 30). Consequently, ss. NR 128.30(3)(a), (6)(c) and (7) are void by statute as of July 1, 1985. The attached order repeals the void sections.

Chapter 1, Laws of 1981 renumbered and amended s. 144.24(10) of the statutes to 144.245, 144.245(1) to (3), (5) to (9)(a), (11) to (12)(c), (14)(a), (14)(c) and (14)(d). The attached order amends citations to 144.24(10) to the appropriate citations as amended by Chapter 1, Laws of 1981.

Pursuant to the authority vested in the State of Wisconsin Department of Natural Resources Board by ss. 144.025, 144.245(2) and 227.014(2)(a) and (c), Stats., the State of Wisconsin Natural Resources Board hereby amends NR 128.30, Wis. Adm. Code, interpreting s. 144.245(11), Stats., as follows:

SECTION 1. NR 128.30(3)(a), (6)(c) and (7) are repealed.

SECTION 2. CROSS-REFERENCE CHANGES. In the sections of the code listed in Column A, the cross-references shown in Column B are changed to the cross-references shown in Column C:




