ORDER OF THE STATE OF WISCONSIN
 NATURAL RESOURCES BOARD
 REPEALING AND RECREATING RULES

.....
 IN THE MATTER of repealing and recreating .
 s. NR 20.02(1)(d)1. and 2. of the Wisconsin .
 Administrative Code pertaining to trout and . F-14-85
 salmon sport fishing on the Great Lakes and .
 Green Bay .

Analysis Prepared by Department of Natural Resources

The rule reduces the lake trout daily bag limit from 3 to 2 fish, establishes an 8-month closed season for lake trout in Green Bay and most of Lake Michigan, and closes the lake trout season in a spawning and nursery area between Algoma and the Sturgeon Bay ship canal. No changes are made in the rules for Lake Superior.

Pursuant to authority vested in the State of Wisconsin Natural Resources Board by ss. 29.085, 29.174(2)(a), and 227.014(2)(a), Stats., the State of Wisconsin Natural Resources Board hereby repeals and recreates rules interpreting ss. 23.09(2)(intro.), 29.085 and 29.174(2)(a), Stats., as follows:

SECTION 1. NR 20.02(1)(d)1. and 2. are repealed and recreated to read:

2. LAKE TROUT	a. Lake Michigan, except as provided in subpar. b., and Green Bay	May 1 through Labor Day	2	10
	b. Lake Michigan, within the following area: from the end of the south pier at the entrance of the Sturgeon Bay ship canal on a course of 136° for 17.5 nautical miles, then west for 16.8 nautical miles to the end of the Algoma north pier, then along the north side of that pier to the shore of Lake Michigan, then north along the shore to the base of the south pier at the entrance of the Sturgeon Bay ship canal, then along the south side of that pier to its end.	No open season		

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on January 23, 1986.

The rules contained herein shall take effect on June 1, 1986.


