AMENDING, OR ADOPTING RULES

AN ORDER to amend VE 2.03, relating to educational qualifications.

Analysis prepared by the department of regulation and licensing.

ANALYSIS

;

Provisions in current s. VE 2.03, relating to educational qualifications, require for admittance to the national board examination for veterinary medical licensing (NBE) and the clinical competency test (CCT) that a graduate of a foreign veterinary school complete the certification program of the education commission for foreign veterinary graduates (ECFVG) of the American veterinary medical association. In order to qualify for a certificate from the ECFVG program, however, a foreign graduate who is enrolled in the program must provide evidence to the ECFVG that he or she has successfully passed the NBE and CCT, which are administered by the veterinary examining board.

In this order, s. VE 2.03, relating to educational qualifications, is amended to require that a foreign graduate provide evidence satisfactory to the board, as the educational condition for admittance to the NBE and CCT, that he or she is enrolled in the ECFVG certification program.

The rule is further amended to specify that a foreign graduate applicant for license to practice veterinary medicine must provide evidence of completion of the ECFVG certification program prior to admittance to the state examination on Wisconsin principles for practice. This particular examination is not part of the existing conflict; therefore, a foreign graduate's ability to complete the ECFVG certification program is not affected by this provision.

Section VE 2.03 interrets s. 453.06(1), Stats., relating to examination and license requirements.

The rule in this proposal was published as an emergency rule on October 23, 1985.

ORDER

Pursuant to authority vested in the veterinary examining board in ss. 15.08(5)(b), 227.014(2)(a) and 453.06(1), Stats., the veterinary examining board hereby amends and adopts rules, interpreting s. 453.06(1), Stats., as follows:

SECTION 1. VE 2.03 is amended to read:

VE 2.03 EDUCATIONAL QUALIFICATIONS. Applicants for license shall submit proof of graduation from an approved school of veterinary medicine. Schools in the United States and Canada, approved by the American veterinary medical association, are approved by the board. Graduates of schools outside the United States and Ganada are required to complete the educational commission for foreign veterinary graduates certification program of the American veterinary medical association as a pre-requisite to eligibility for examination. The educational foreign veterinary graduates certificate shall accompany the application for examination. be eligible for admission in Wisconsin to the national board examination and clinical competency test, graduates of schools outside the United States and Canada are required to either be enrolled in the educational commission for foreign veterinary graduates certification program of the American veterinary medical association or be undertaking intern or resident training at a school of veterinary medicine in this state. foreign veterinary graduate shall provide proof satisfactory to the board of completion of the educational commission's certification program as a precequisite for admission to the Wisconsin principles of practice examination. Temporary permits may be issued by the board but only to graduates of schools in the United States and Canada only.

The rules adopted in this order shall take effect on the first day of the month following publication in the Misconsin administrative register, pursuant to s. 227.026(1) (intro.), Stats.
