# ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING RULES

IN THE MATTER of amending s. NR 20.03(2)(a) . of the Wisconsin Administrative Code . pertaining to lake sturgeon registration . hours during the spear fishing season. .

F-46-86

#### Analysis Prepared by Department of Natural Resources

The rules are promulgated under the authority of ss. 29.174(3), 227.11(2)(a) and 227.16(2)(e), Stats., and interpret s. 29.174(2), Stats.

The proposed rule will extend the lake sturgeon registration requirement for lake sturgeon speared through the ice on designated Winnebago and upriver lakes from 6:00 p.m. to 7:00 p.m. on the day the lake sturgeon is speared.

#### SECTION 1. NR 20.03(2)(a) is amended to read:

NR 20.03(2)(a) Each person who has speared a sturgeon during the open season for spearing sturgeon shall exhibit such the sturgeon, with his the person's sturgeon tag attached as required by s. 29.148, Stats., to a warden or other authorized department personnel at an official sturgeon registration station established for such that purpose. Such-sturgeon Sturgeon shall be so exhibited at such a sturgeon registration station in a county adjacent to the waters where speared not later than 6:00 7:00 p.m. on the day speared. Upon approval by the officer, said the officer shall attach a special tag to each sturgeon indicating that it has been inspected and recorded and such the tag small remain attached and locked to such the sturgeon until the carcass is finally consumed.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on September 18, 1986.
