ORDER OF THE WISCONSIN NATURAL RESOURCES BOARD  
AMENDING, AND REPEALING AND RECREATING RULES

Analysis Prepared by the

The rules are promulgated under the authority of ss. 29.103(3) and (4), 29.174(3) and 227.16 (2)(e), Stats., and interpret s. 29.103 and 29.174(2)(b), Stats.

The number of turkey hunting permits issued by the department controls the turkey harvest in 7 wild turkey hunting zones. The department proposes to expand the hunting season framework from 3, 5-day to 4, 5-day hunting periods as well as increase the number of permits to 6,040. In 1986, 3,495 permits were issued and 793 wild turkeys were harvested.

SECTION 1. NR 10.01(2)(f)1. is amended to read:




