ORDER

Pursuant to authority vested in the Wisconsin funeral directors examining board by ss. 15.08(5)(b), 227.11, 445.03(2) and 445.125(2), Stats., the funeral directors examining board hereby creates and adopts rules, interpreting s. 445.125(2), Stats., as follows:

SECTION 1. FDE 3.01(11) is created to read:

FDE 3.01(11) Failing to provide to the depositor, within 15 working days of receipt of a payment, written confirmation of receipt and deposit of payment made pursuant to a funeral trust agreement in accordance with s. 445.125(2), Stats. Such written confirmation shall include the name of the bank, trust company, savings and loan association or credit union, the account number, the date of deposit, and a copy of the deposit slip or other documentary evidence of a payment deposited.

The rule created and adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026(1)(a), Stats.
