ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING AND CREATING RULES

IN THE MATTER of amending s. NR 20.04(4)(a)5. and creating s. NR 20.03(1)(g)2. of the Wisconsin Administrative Code pertaining to closing the lake trout open fishing season in Pallette Lake, Vilas County

Analysis Prepared by Department of Natural Resources

The rule is promulgated under the authority of ss. 29.174(3) and 227.11(2)(a), Stats., and interprets s. 29.174(2), Stats.

The proposed rule provides a year-round closed season for lake trout in Pallette lake, Vilas county.

SECTION 1. NR 20.03(1)(g)2. is created to read:

Kind of fish and locality	Open season (both) dates inclusive)	Daily bag limit	Minimum length (inches)
2. Pallette lake, Vilas county	No open season through 1991		

SECTION 2. NR 20.04(4)(a)5. is amended to read:

NR 20.04(4)(a)5. There is a continuous open season with no daily bag limit or size limit for all species of fish contained in these waters except in Nebish lake there shall be a 10-inch minimum size limit for smallmouth bass, a 17-ineh-minimum-size-limit-on no open season through 1991 for lake trout in Pallette lake and a 12-inch minimum size limit with a 2 daily bag limit on largemouth bass in Spruce lake.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on December 18, 1986

The rules shall take effect as provided in s. 227.22(2)(intro.), Stats.
