ORDER OF THE WISCONSIN NATURAL
RESOURCES BOARD REPEALING, AMENDING
AND RECREATING AND CREATING RULES

IN THE MATTER of repealing s.
NR 10.24 (6)(c)3., amending ss. NR
10.24 (3)(c)2. and (6)(c)2.b.; and
creating s. NR 10.24 (2)(a) to (c),
(3)(a), (b) and (d) to (g), (4)(a)
to (g), (6)(a) to (e), (7)(a) and
(b), (8)(a) and (b), and (9)(a) and
(b)(titles) pertaining to Bong State
Recreation Area hunting.

Analysis Prepared by Department of Natural Resources

Current rules restrict the number of daily hunting permits to 300 during the entire pheasant season. Further, hunting hours conform to those established for statewide hunting.

Rule modification establishes a 300-permit limit for the entire season and restricts the opening of all hunting except waterfowl and deer hunting to 9:00 a.m. daily. The rules are designed to increase hunter satisfaction by reducing pheasant hunting competition and separating early morning waterfowl hunters from other hunters. Titles are created for housekeeping purpose.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board ss. 23.091(3), 29.174(1), and 227.11(2)(a), Stats., the State of Wisconsin Natural Resources Board hereby repeals, repeals and recreates and creates rules interpreting s. 29.174(2)(a), Stats., as follows:

SECTION 1. NR 10.24(2)(a) to (c), (3)(a), (b) and (d) to (g), (4)(a) to (g), (6)(a) to (e), (7)(a) and (b), (8)(a) and (b) and (9)(a) and (b) (titles) are created to read:

- (2)(a) General prohibition.
- (b) Firearms.
- (c) Other hunting methods.
- (3)(a) General prohibition.
- (b) Limitations.
- (d) Waterfowl.
- (e) Trapping.
- (f) Legal game.
- (g) Disposal.
- (4)(a) Application period.
- (b) Application limit.
- (c) Random selection.
- (d) Application after deadline.
- (e) Reservation limit.
- (f) Check-in deadline.

- (g) Other standards.
- (6)(a) General restrictions.
- (b) Waterfowl and deer hours.
- (c) Pheasant season exception.
- (d) Special closure.
- (e) Trapping hours.
- (7)(a) Tagging.
- (b) Tag retention.
- (8)(a) Blind requirement.
- (b) Blind limitation.
- (9)(a) Permit duration.
- (b) Other limitations.

SECTION 2. NR 10.24(3)(c)2. and (6)(c) 2.b. are amended to read:

NR 10.24(3)(c)2. Beginning with the 15th day of the pheasant season, the number of daily hunting permits issued to individuals may not exceed 300 until 10:00 a.m. After 10:00 a.m., additional hunting permits may be issued on a first-come, first-served basis. ~~Beginning in 1986, this subdivision shall apply during the entire pheasant season.~~

NR 10.24(6)(c)2.b. The Sunday nearest October 17 and running for 13 consecutive days -- ~~8:00~~ 9:00 a.m. ~~G.S.F.~~

SECTION 3. NR 10.24 (6)(c)3. is repealed.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on February 26, 1987.

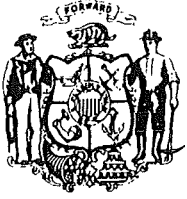


