ORDER

The Pharmacy Examining Board adopts an order to create Phar 7.05(5), relating to the use of computerized systems to maintain prescription renewal information.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Computerized systems are increasingly being used by pharmacists to maintain records of prescription orders received and prescriptions dispensed to individual consumers. In this order, s. Phar 7.05(5) is created to clearly indicate that such recordkeeping systems are appropriate, set forth the data retrieval capabilities, and the availability of auxiliary procedures in the event of system down-time. The rule interprets the requirements set forth in ss. 450.11(2) and (5).

TEXT OF THE RULE

SECTION 1. Phar 7.05(5) is created to read:

Phar 7.05(5). A computerized system may be used for maintaining a record of prescription dispensing and transfers of original prescription order information for the purposes of renewal dispensing, as required under this section, if the system:

(a) Is capable of producing a printout of any prescription data which the user pharmacy is responsible for maintaining. The system shall be designed so that the pharmacy can receive the printout within 48 hours after requesting the printout.

(b) Is equipped with an auxiliary procedure which, during periods of down-time, shall be used for documentation of prescription dispensing. The auxiliary procedure shall ensure that prescription renewals are authorized by the original prescription order, that the maximum number of prescription renewals has not been exceeded and that all of the appropriate data are retained for on-line entry as soon as the computer system is again available for use.

This rule shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22(2), Stats.
