AN ORDER to amend C 1.02(11) and (12), 2.07(1) and (2), 2.15(1), 4.04 and 7.01(intro.); and to create C 1.02(19), relating to sanitation standards and practice requirements.

ANALYSIS

In this proposal, ss. C 1.02(11) and (12) are amended to include requirements for storage of clean and soiled paper products as well as clean and soiled linen. Subsection (19) in s. C 1.02 is created to specify disinfectants that may be used by licensees in practice.

C 2.07(1) and (2) are amended to clarify that the definition of "licensed instructor" in C 2.07(1) applies only to C 2.07, and that the definition of "other qualified instructor" in C 2.07(2) applies only to C 2.07, and not to all of Chapter C 2.

Also, various provisions are amended to make technical changes and to change as appropriate obsolete statutory references.

The rules in this proposal interpret s. 458.03(1), Stats., relating to supervision by the examining board and regulations.

ORDER

Pursuant to authority vested in the cosmetology examining board in ss. 15.08(5)(b), 227.11, and 458.03(1), Stats., the cosmetology examining board hereby amends and creates rules, interpreting s. 458.03(1), Stats., as follows:

SECTION 1. C 1.02(11) and (12) are amended to read:

C 1.02(11) Containers of adequate size and construction shall be provided to store all soiled linen and used paper products. All soiled linen and used paper products shall be immediately stored after use. Towels shall be properly laundered in hot soapy water of at least 135° Fahrenheit; or, if cold water is used, a disinfecting agent ~~must~~ shall be added according to manufacturer directions.

C 1.02(12) Clean containers shall be provided for all clean linen and paper products.

SECTION 2. C 1.02(19) is created to read:

C 1.02(19) Disinfectants which may be used by licensees as defined by C 1.01(2) include, but are not limited to:

- (a) 70% alcohol,
- (b) 1600 PPM quaternary ammonium compound,
- (c) 15% lysol,
- (d) 5% phenol, and
- (e) 200 PPM sodium hydrochloride (chlorine bleach).

SECTION 3. C 2.07(1) and (2) are amended to read:

C 2.07(1) ~~For the purposes of this rule~~ In this section "licensed instructor" means, a person holding a license or temporary permit as an instructor granted by the cosmetology examining board.

C 2.07(2) ~~For the purposes of this rule~~ In this section "other qualified instructor" means a person who meets the qualifications of s. 458.08(10), Stats., and who is employed by a cosmetology school to teach the subjects of hygiene, histology, anatomy, elementary chemistry or general science.

SECTION 4. C 3.01(1)(d) is amended to read:

C 3.01(1)(d) If under 18 - proof of education as required by s. ~~459.12~~ 458.12, Stats.

SECTION 5. C 2.15(1) is amended to read:

C 2.15(1) In order for a school to teach the junior instructor course it ~~must~~ shall be licensed under ch. ~~459~~ 458, Stats., as a school of cosmetology or be an approved institution offering related courses approved by the board. A combination of courses offered by both types of schools would also be acceptable.

SECTION 6. C 4.04 is amended to read:

C 4.04 FAILURE TO OBTAIN LICENSE. Any person who passes an examination for licensure and fails to obtain ~~such~~ the license within one year of passing the examination shall be required to comply with s. ~~459.10~~ 458.10, Stats., in order to obtain ~~such~~ the license.

SECTION 7. C 7.01(intro.) is amended to read:

C 7.01(intro.) UNPROFESSIONAL CONDUCT OR PRACTICE. All persons licensed under ch. ~~459~~ 458, Stats., shall practice and conduct themselves in a professional manner at all times. Unprofessional conduct or practice shall include but not be limited to the following:

The rules amended and created in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22(1)(2), Stats.
