

AMENDING A RULE

To create Ins 17.25 (5) (a) 2m, relating to liability insurance  
coverage for nurse practitioners.

ANALYSIS PREPARED BY THE OFFICE OF THE COMMISSIONER OF INSURANCE

Statutory authority: ss. 601.41 (3) and 619.04 (10), Stats.

Statute interpreted: s. 619.01 (1), Stats.

This rule makes registered nurse practitioners who meet the certification or educational requirements for nurse practitioners specified by the department of health and social services eligible to obtain health care professional liability insurance through the Wisconsin health care liability insurance plan authorized by ch. 619, Stats. Insurance coverage will be available to nurse practitioners up to the limits expressed in s. 655.23 (4), Stats., at a rate determined by the board of governors of the plan.




