Analysis Prepared by the Wisconsin Department of Transportation

General Summary of Proposed Rule. Chapter Trans 325 adopted motor carrier safety regulations of the United States department of transportation in effect on October 1, 1984. This proposed amendment changes the date from October 1, 1984 to October 1, 1987. This change allows Wisconsin to enforce the most recent version of the motor carrier safety regulations. All vehicles operating in interstate commerce are already subject under federal law, to any changes that have been adopted between October 1, 1984 and October 1, 1987.

Fiscal estimate. This rule change will not have a fiscal effect upon the state, any local governments or the private sector.

Regulatory of flexibility analysis. This rule change will not have an effect upon any small businesses.

Rule Text

SECTION 1. TRANS 325.01 is amended to read:

Trans 325.01 FEDERAL RULES ADOPTED. The following federal motor carrier safety regulations adopted by the United States department of transportation and in effect on ~~October 1, 1984~~ October 1, 1987, are adopted by the department and shall be enforced in relation to those carriers, drivers or vehicles to which these federal rules apply in the same manner as though the regulations were set out in full in this section:

(1) Title 49, Code of Federal Regulations, part 390, federal motor carrier safety regulations - general;

(2) Title 49, Code of Federal Regulations, part 391, qualifications of drivers;

(3) Title 49, Code of Federal Regulations, part 392, driving of motor vehicles;

(4) Title 49, Code of Federal Regulations, part 393, parts and accessories necessary for safe operation;

(5) Title 49, Code of Federal Regulations, part 395, hours of service of drivers;

(6) Title 49, Code of Federal Regulations, part 396, inspection, repair and maintenance.


(7) Title 49, Code of Federal Regulations, part 397, transportation of hazardous materials; driving and parking rules.

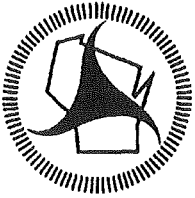
This rule shall take effect on the first day of the month following publication in the Wisconsin Administrative Register as provided in s. 227.22(2), Stats.
